## MOTION TO USE SURCHARGE PROCEEDS

Comes now, Black Mountain Utility District ("Black Mountain"), by counsel, and respectfully moves the Kentucky Public Service Commission ("Commission") to use proceeds of the Water Loss Reduction Surcharge. In support of this motion, Black Mountain states as follows:

1. In Case 2022-00275<sup>1</sup> the Commission ordered Black Mountain to assess a monthly

Water Loss Reduction Surcharge of \$2.63<sup>2</sup> per active meter to be phased in over three years. The Commission ordered that the surcharge should continue for 48 months, or until \$319,316.00 has been assessed, whichever occurred first.

2. On October 9, 2023, the Commission established this proceeding to monitor Black Mountain's Water Loss Reduction Surcharge. The Commission found that before Black Mountain District can utilize any proceeds from the surcharge, Black Mountain must obtain permission from the Commission.<sup>3</sup>

3. On January 25, 2025, Harlan County Judge Executive, Dan Mosley declared a state of emergency for Harlan County due to a water crisis that resulted in approximately 1,900 customers being without water. 1,750 of those customers were Black Mountain customers.

4. Black Mountain's Manager had previously given his notice of resignation which was to be effective the same day that the state of emergency was declared. That same week, two other Black Mountain employees resigned. These resignations essentially cut Black Mountain's field staff from six employees down to three.

5. Judge Mosley requested that additional personnel be dispatched from several regional water districts to help. Over the course of a five-day period, employees from Cumberland Falls Water District, Wood Creek Water District, City of Middlesboro, Water Service Corps of Kentucky, and Caywood Water District assisted Black Mountain on various water restoration efforts.

6. During this state of emergency, it was discovered that the telemetry system was not working throughout the system. The telemetry system is essential to alert Black Mountain when there is a problem with a tank or if the water level in a tank declines. Without telemetry, employees have to drive to each tank to check water levels.

7. While employees were checking the tank levels, the Board was alerted that the pumps at Daniels Mountain, Dayhoit, Slickey Ridge, Putney Booster Pump Station, and Pine Mountain were either not operational or leaking water from the pumps in large volumes; and therefore, water that was being acquired from the City of Harlan was not making it into the tanks to serve customers.

8. Necessary repairs had to be made to Black Mountain's system to restore operations and to prevent water loss. As such, Black Mountain incurred necessary costs and requests the Commission grant approval to use the water loss surcharge to cover those costs.

9. As of February 14, 2025, the surcharge contains \$134,628.42.<sup>4</sup> Black Mountain requests the Commission allow an additional \$75,736.25 in surcharge funds to be used for the necessary repairs and upgrades. The invoices and quotes for the emergency services and repairs are provided as Attachment A and as Excel spreadsheets provided separately.

WEREFORE, Black Mountain moves the Commission to permit Black Mountain District to use \$75,736.25 of its Water Loss Reduction Surcharge to pay for the parts and repairs at six (6) different locations and to be reimbursed for the time and travel included in the invoices.


