RE: Formal Application to Increase Rates Pursuant to
Purchased Water Adjustment Regulation 807 KAR 5:068

Dear Ms. Bridwell:

The U.S. 60 Water District respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The District was recently notified by its supplier, the Shelbyville Municipal Water & Sewer Commission, that it would increase its wholesale rates by \$0.06 per 1000 gallons. This increase will take effect on July 19, 2023. The result of this increase is \$9,954.12 in additional annual supply cost for the District. This translates into \$0.07 per 1000 gallons of water sold to our customers. Therefore, we propose to increase our rates by that amount.

The Shelbyville Municipal Water & Sewer Commission (SMW&SC) Is providing notice that on February 15, 2021 a proposed increase in water rates was approved by the Commission, including wholesale water rates to Water Districts, and recommended these changes to the City Council which had their 1st reading on March 4, 2021, with the 2nd reading scheduled for March 18, 2021. This ordinance allowed the Commission to do annual increases of 2.5% annually to all water and sewer customers. The SMW&SC is in process of filing this week with the Public Service Commission the wholesale Rates it shall charge the North Shelby Water District, and the U.S. 60 Water District. These rates will be effective for water service rendered on and after July 19, 2023. The proposed rates are as follows:

Quantities over the respective Contract Limits shall be charged the PROPOSED Rate described above, plus \$1.00 per 1,000 gallons.

The Shelbyville City Council had the 1st hearing on March 4, 2021 and the 2nd hearing will be on March 18, 2021. Water flowing through the meter(s) before the effective date will be charged at the current rates while water is flowing through the meter(s) on and after the effective date (July 19, 2023) will be charged at the proposed rates.

As noted above, based on the increased cost of water from the Shelbyville Municipal Water & Sewer Commission, all rates will increase \$0.07 per 1,000 gallons. The monthly bill for a typical residential customer using an average of 4,390 gallons of water each month will increase from \$47.77 to \$48.08. This is an increase of \$0.31 or 0.65%.

The charges/rates contained in this notice are the charges/rates proposed by the U.S. 60 Water District. However, the Public Service Commission may order charges/rates to be charged that differ from these proposed charges/rates. Such action may result in charges/rates for consumers other than the charges/rates detailed in this notice.


RESOLUTION OF AUTHORIZATION

Action herein ordered shall be duly recorded in the minutes of this public meeting of the U.S. 60 Water District held on this the 20th day of June 2023.


