Dear Ms. Bridwell:

The North Shelby Water Company respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The Company was recently notified by its supplier, Louisville Water Company, that it will increase meter service charges by \$1.92 per month and increase wholesale rates by \$0.08 per 1000 gallons. These changes will take effect on July 1, 2022. The Company was also recently notified by another supplier, the Shelbyville Municipal Water & Sewer Commission, that it would increase its wholesale rates by \$0.06 per 1000 gallons. This increase will take effect on July 19, 2023. The combined result of these increases is \$36,620.45 in additional yearly supply cost for the Company. This translates into \$0.09 per 1000 gallons of water sold to our customers. Therefore, we propose to increase our rates by that amount.

On behalf of Louisville Water Company, thank you for attending the meeting of our wholesale customers held on March 7, 2023. We hope you found the information we shared beneficial.

As previously discussed at the above meeting, the proposed wholesale commodity charge effective July 1, 2023 will be \$2.13 per thousand gallons, plus an elevated service area surcharge of \$0.50 per thousand gallons, for a total wholesale rate of \$2.63 per thousand gallons. This represents a 3.1% increase of the current rate.

We are planning to file the necessary documentation for this proposed new rate with the Public Service Commission (PSC) near the end of March. The PSC has advised us in the past that we must inform you of the proposed rate increase in the format of the notice attached on the next page, although we have already provided you notice at our wholesale customer meeting March 7, 2023.
