
Comes now CUMBERLAND WATER DISTRICT (hereinafter "District"), by Counsel,
pursuant to Order of November 3, 2023 and for its Response does state as follows:

1. **RESPONSE:** Term length is determined by the fiscal court.
2. **RESPONSE:** The normal term is 3 years
3. **RESPONSE:** (a) July 9, 2012

7. **RESPONSE:** To the best of my knowledge, a normal 3-year term would end in 2023, but the fiscal court minutes reflect Mr. Cary's term ending 4/30/2025. Beyond this the reason for such discrepancy is unknown to me.
8. **RESPONSE:** The fiscal court minutes reflect Mr. Cary's term ending 4/30/2025.

10. **RESPONSE:** Mr. Vibbert's term did expire in December of 2014. He was reappointed to another 3-year term, and Mr. Vibbert was again re-appointed to a 3-year term at the May 9, 2017 fiscal court meeting. He was reappointed at the April 13, 2020 fiscal court meeting to an additional term. It was assumed by all this was an additional 3 year term.
11. **RESPONSE:** Mr. Vibbert's appointment was in 2014. Mr. Vibbert was re-appointed to a 3-year term at the May 9, 2017 fiscal court meeting. He was reappointed at the April 13, 2020 fiscal court meeting to an additional term. It was assumed by all this was an additional 3 year term. *See Attached Documentation in support thereof.*
12. **RESPONSE:** To the best of my knowledge it was just an oversight by auditors and management.
13. **RESPONSE:** To the best of my knowledge, a normal 3 year term would end in 2023, but the fiscal court minutes do reflect Mr. Vibbert's term ending 4/30/2025. Beyond this the reason for such discrepancy is unknown to me.
