Each day during the billing period we begin with the total balance you owe on the account at the beginning of the day, then we add in any new loan advances which were made on that day and any additional charges which were assessed against the account that day; then, if applicable, we subtract out (i) all payments received and credits applied on that day and (ii) all unpaid finance charges, annual charges, insurance charges or other charges which were included in your total account balance on that day.
