



On or about August 18, 2023, Hardin County Water District No. 1 will file an application with the Public Service Commission to adjust its rates for sewer service. Hardin County Water District No. 1's application will be filed pursuant to the procedures set forth in 807 KAR 5:076. Under those procedures, the proposed rates may not be placed into effect until the Public Service Commission has issued an order approving the proposed rates or six (6) months from the date of the filing of the application, whichever occurs first. The proposed rates are shown below.

If the Public Service Commission approves the proposed sewer rates, the monthly sewer bill for a retail customer using an average of 4,000 gallons per month will increase \$5.61 from \$32.43 to \$38.04, or 17.3%. Hardin County Water District No. 1 currently has no wholesale customers.

The Public Service Commission has established Case No. 2023-00242 to review Hardin County Water District No. 1's application. LEGAL

FINDING OF NO PRACTICABLE ALTERNATIVE (FONPA)
Pursuant to EOs 11988, Floodplain Management, 13690, Establishing a Federal Flood Risk Management Standard and a Process for Further Solicitation and Considering Stakeholder Input, and 11990, Protection of Wetlands, the Army must find there are no practicable alternatives to construct in a floodplain or wetland, and to do so, all practicable measures should be taken to minimize harm to the floodplain and wetland. The practicability of a given alternative is evaluated by considering such pertinent factors as operational impact and environmental impact in light of the overall project purpose.

In this instance, avoiding floodplain entirely for the proposed construction of an Ammunition Staging Facility at McFarland Oliver (MFO) Range is unrealistic due to the location of the proposed project and its proximity to suitable, available impact area on Fort Knox. Because floodplains are linked to adjacent streams and rivers, the installation will require engineers and contractors to design and construct so that runoff from rain events will not adversely impact (a) existing streams, (b) upstream systems, and (c) downstream systems within the proposed action location. This will help to maintain stormwater flow at the same levels during pre- and post-construction periods, which will contribute to the preservation of water storage and conveyance, and the filtering of pollutants from runoff.

The installation will also mandate full utilization of Best Management Practices, National Pollution Discharge Elimination System permit requirements, site-specific Stormwater Pollution Prevention Plan, and other pre- and post-construction BMPs to reduce the potential adverse impact to water bodies.

Wetland impacts were avoided during design and the siting of the Ammunition Staging Facility. No new impermeable surfaces or structures associated with the facility at the MFO Range site will be built in wetlands.

After careful consideration of the information presented, I find there is no practicable alternative to constructing the Ammunition Staging Facility at the MFO Range site in the floodplain. I further find that all practicable measures have been taken to minimize harm to floodplain and wetland, and those measures are documented in the Record of Environmental Consideration titled MFO Ammunition Staging Facility and Table 1 of this decision document. This finding fulfills the requirements of EOs, 11988, Floodplain Management, 13690, Establishing a Federal Flood Risk Management Standard and a Process for Further Solicitation and Considering Stakeholder Input, and 11990, Protection of Wetlands.

Titans relieved that WR Burks' knee injury isn't serious

Tennessee Titans have avoided a major injury for wide receiver Treyton

Burks' left knee. Titans coach Mike Vrabel said Thursday after the second day of joint practice with the Minnesota Vikings that Burks suffered no structural damage. NFL Network, citing unidentified sources, reported that Burks sprained his lateral collateral ligament and will be sidelined for at least two weeks. The LCL stretches along the outside of the knee from the femur to the fibula. Burks was hurt Wednesday after catching a deep pass in a one-on-one drill, when he fell to the grass after stumbling forward and needed assistance off the field after limping to his feet and clutching his knee.

USA is in great position entering Round 2 of the World Cup

MANILA, Philippines — The opponent names will become more recognizable for USA Basketball now. Nikola Vucevic awaits on Friday, Jonas Valanciunas on Sunday, and if the Americans keep progressing through this FIBA World Cup the challenges will only get tougher.

To that, they say this: Good.

Second-round play at the World Cup starts Friday, with a 32-team field to start the tournament now down to 16 contenders for the Naismith Trophy. The U.S. is one of eight teams with 3-0 records, and those are the teams that have the easiest path to

the quarterfinals.

“There’s an immediate respect level from guys going against them in the NBA,” U.S. coach Steve Kerr said. “The familiarity really helps as well. The hard part is when you go into a game and there’s a great player who these guys don’t know, and he’s got a last name with lots of letters, and you have to refer to him as No. 5 or whatever and our guys aren’t ready for how good this player is. That’s a huge challenge in this tournament.”

Not anymore. Nobody will need to Google most of the best players on the teams that made Round 2. Luka Doncic is headed there, along with Shai

Gilgeous-Alexander, Karl-Anthony Towns, Dennis Schroder, Patty Mills, Bogdan Bogdanovic, Vucevic and Valanciunas — among others.

In Round 2, the U.S. plays Montenegro on Friday and Lithuania on Sunday.

“For us as a country, to get to play against the U.S. will be a huge thing,” said Vucevic, Montenegro’s best player. “We have to go out there and show our best ... and enjoy that game.”

Joining the U.S. in Round 2 with 3-0 records out of group play are Slovenia, defending World Cup champion Spain, Canada, Germany, Serbia, the Dominican Republic and Lithuania. For those eight teams, the task is this simple: Win two games this

weekend, and the quarterfinals are certain. Each could also lose one of their next two games and still advance.

Also in the second-round field are eight teams that advanced with 2-1 records: Montenegro, Greece, Italy, Puerto Rico, Australia, Georgia, Brazil and Latvia.

The Americans are the only team in the tournament that have won every game so far by at least 27 points. Canada’s closest win margin so far is 26; Lithuania’s is 20.

“Nothing changes,” U.S. captain Jalen Brunson said. “The approach has to be the same. It’s almost the knockout stage, and we approach the game like it’s our last game every game. We’ve got to keep that same mentality. There’s just a lot more at stake now.”

There’s more than just the World Cup at stake, even.

Australia has already qualified for next year’s Paris Olympics. All 15 remaining second-round teams are still in the mix to clinch an automatic berth in those games based on their finish here; two of the five Americas teams will get Olympic spots, two of the 10 European teams left will get them as well.

For those teams that keep winning, the Olympic spots will take care of themselves.

“Our goal, our first goal, was to win the group stage,” said Gilgeous-Alexander, Canada’s top player and one of two current All-NBA players in the tournament — Doncic, the Dallas star who leads Slovenia, being the other. “But we’re not done. We’re not satisfied. And we have

five more games to try to go win.”

Canada is bidding for its first World Cup medal ever. There will be at least two teams on the medal podium that didn’t get there at the last World Cup in 2019; Spain — which has an 11-game World Cup winning streak — is still alive, but silver medalist Argentina didn’t qualify for this tournament and bronze medalist France was ousted in Round 1.

“Our goal for this season was to make it to the quarterfinals and then relax and see what happens,” Spain coach Sergio Scariolo said. “It’s going to be a hell of a challenge.”
