Mr. Kelley has a Bachelor of Science degree in Natural Resources and Environmental Science from the University of Kentucky. He has been an environmental scientist with Stantec for approximately 10 years and is currently the Natural Resources Team Lead Team lead for Stantec's Kentucky Natural Resources team, over which he manages a team of environmental professionals who specialize in renewables, environmental permitting, the endangered species act, wetland delineations, habitat assessments, Section 7 consultation, 401/404 permitting, hazardous materials assessments, and Phase I ESAs.

Dr. Paul Coomes will be available to provide testimony on the economic impact that the Project will have both in the local and regional areas. His report was filed with the application and supplements thereto have been provided in response to data requests. Dr. Coomes has a Ph.D. in Economics and is a Professor Emeritus of Economics at the University of Louisville, where he started teaching in 1985. Dr. Coomes has provided services to several renewable-energy projects submitted to the Siting Board.

Richard Kirkland will be available to provide testimony on the Kirkland Appraisals property-value report that was filed with the application, as well as respond to questions. Mr. Kirkland has served as an appraiser since 1996. He is a Kentucky and North Carolina State Certified Appraiser, and obtained an MAI Designation in 2001. Mr. Kirkland has submitted numerous property-value reports associated with solar-energy generating facilities that have been accepted by the Kentucky Siting Board.
