PETITION FOR CONFIDENTIAL TREATMENT

Dogwood Corners LLC (“Dogwood Corners”), by counsel, moves the Kentucky Siting Board on Electric Generation and Transmission Siting (the “Siting Board”) for an order granting confidential treatment to certain information and documents filed the response to the Siting Board’s Post-Hearing Data Requests. Specifically, Dogwood Corners requests confidential treatment for information contained in documents responsive to Item 1. In support of this motion, Dogwood Corners states as follows:

The Kentucky Open Records Act exempts certain records from the requirement of public inspection. *See* KRS 61.878. In particular, KRS 61.878(1)(a) exempts from disclosure “[p]ublic records containing information of a personal nature where the public disclosure thereof would constitute a clearly unwarranted invasion of personal privacy.” In enacting this provision, the General Assembly acknowledged “that personal privacy is of legitimate concern and worthy of protection from invasion by unwarranted public scrutiny.” *Kentucky Bd. of Exam'rs of Psychologists v. Courier–Journal*, 826 S.W.2d 324, 327 (Ky. 1992).

Public Service Commission regulations suggest that certain information paired with an individual's name, such as home addresses of non-parties, is considered "personal information". 807 KAR 5:011, Section 4(10). In response to Item 1, Dogwood Corners is providing the information, which contains individual's names and addresses. Accordingly, the individuals' names should be protected from public disclosure because it contains personal information

For the foregoing reasons for an indefinite amount of time, Dogwood Corners respectfully requests confidential treatment of the individuals' names, consistent with 807 KAR 5:001, Section 4(10).
