MOTION TO RESCHEDULE HEARING

Oldham County Water District (“Oldham District”), by counsel, moves the Public Service Commission (“Commission”) for an Order rescheduling the hearing in this matter. In support of this Motion, Oldham District states the following:

1. The hearing date in this matter is currently set for April 2, 2024, pursuant to the Commission’s Order of March 14, 2024.
2. Oldham District intends to call two witnesses to participate in person at the hearing.
3. One of Oldham District’s witnesses will be out of the state on Spring Break vacation with family and unavailable to testify for the entire week of April 1 – 5, 2024. As such, good cause exists to reschedule the hearing date from April 2, 2024.

4. Both of Oldham District’s witnesses will be available to appear at a hearing in this matter on any day between April 9th and May 10th of 2024, **except** for the following dates: **April 16th, April 18th, and May 8th.**

5. The local newspaper, *The Oldham Era*, is a weekly publication and is published on Thursday of each week. Requests for publishing a legal notice must be submitted to the newspaper by Friday of the previous week. Because of this long “lead” time, Oldham District requests that the Commission provide at least **sixteen (16) days advance notice** of the new hearing date to ensure that notice is provided to the public at least seven (7) days before the hearing as required by 807 KAR 5:001, Section 9(2).

WHEREFORE, Oldham County Water District requests that the Commission enter an Order rescheduling the April 2, 2024 hearing to any date convenient for the Commission between April 9 – May 10, 2024, except for the three conflicting dates referenced in paragraph 4.
