**MOTION FOR INFORMAL CONFERENCE**

---

By and through the undersigned counsel, and pursuant to 807 KAR 5:001, Section 5 and Section 9(4), Oldham County Water District (“Oldham District”) requests an informal conference with Commission Staff for the purpose of discussing the implementation of the September 24, 2025 Order of the Franklin Circuit Court reversing the Commission’s June 18, 2024 Order in this proceeding and the procedure to be used to do so.

In support of its Motion Oldham District states the following:

1. On September 24, 2025, the Franklin Circuit Court reversed the Commission’s June 18, 2024 final Order in this proceeding on the issue of including the full cost of employee health insurance in rates for water service.

2. On October 14, 2025, The Franklin Circuit Court granted Oldham District's Motion to Amend the September 24, 2025 Order and changed certain technical language of the Order without disturbing the decision.

3. The decision of the Franklin Circuit Court became final on November 14, 2025.

4. The Order of the Franklin Circuit Court requires the inclusion of \$125,241, the disputed amount for employee health insurance, in Oldham District's Revenue Requirement when calculating rates.

5. Oldham District requests an informal conference with Staff to present its proposed rates to Staff, answer any questions concerning their calculation, and receive guidance from Staff on the procedure to be followed to implement to the decision of the Franklin Circuit Court.

WHEREFORE, based on the forgoing Oldham District moves for an Order scheduling an informal conference with Commission Staff.
