Following the successful public meeting that we held this past May, Clearway Energy Group LLC ("Clearway") is submitting its application to the Kentucky Electric Generation and Transmission Siting Board ("Board") for a Certificate of Construction for an Electric Solar Generating Facility for the construction and operation of our Song Sparrow Solar project.

The Song Sparrow Solar project will have a nameplate capacity of up to 104 MW-ac across approximately 655 acres and will be sited on private land. The project will consist of solar photovoltaic panels and their associated racking systems, inverters, project substation and utility switching station, roads, perimeter fences and other ancillary equipment. The project will connect to Louisville Gas & Electric / Kentucky Utilities' ("LG&E/KU") electric transmission line that is located within the project area.

The Project has signed a power purchase agreement with LG&E/KU following a competitive solicitation as part of the utility's larger strategy to bolster the power grid. We are pursuing this project with the goal of increasing our nation's energy independence, protecting the reliability of the electric power grid and making significant investments in communities where we serve.
