Clearway Energy Group LLC (Clearway) - one of the largest renewable energy companies in the United States, specializing in the development, financing, construction and operation of solar and wind energy projects – is excited to invite you to a public information meeting to learn more about Clearway’s proposed Song Sparrow Solar project located in western Ballard County between Gage and La Center.

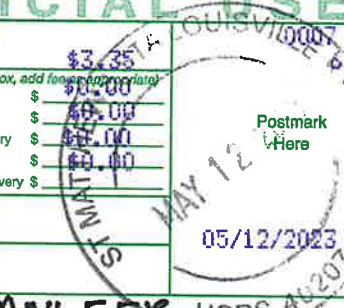

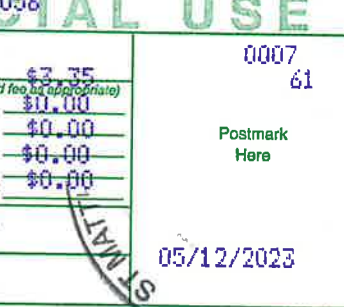

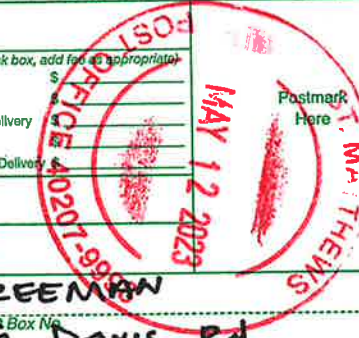
