## MOTION FOR EXTENSION OF TIME APPLICATION FOR CERTIFICATE OF PUBLIC CONVENIENCE POST ORDER

1. On March 28, 2024, Cellco Partnership d/b/a Verizon Wireless (Verizon Wireless) and VB BTS II, LLC d/b/a Vertical Bridge (collectively, Joint Applicants) filed an application seeking a Certificate of Public Convenience and Necessity (CPCN) to construct and operate a wireless telecommunications facility. The proposed facility consists of a tower not to exceed 305 feet in height, with attached antennas, to be located at 3180 Minors Branch Road, Gravel Switch, Casey County, Kentucky. The

coordinates for the proposed facility are North Latitude 37° 30' 33.53" by West Longitude 84° 57' 23.05".

2. On July 12, 2024 the Kentucky Public Service Commission granted a CPCN to construct a wireless telecommunications facility. The proposed facility consists of a tower not to exceed 305 feet in height, with attached antennas, to be located 3180 Minors Branch Road, Gravel Switch, Casey County, Kentucky. The coordinates for the proposed facility are North Latitude 37° 30' 33.53" by West Longitude 84° 57' 23.05".

3. On July 24, 2024 Co-Applicants filed supplemental information including Approval from the Kentucky Airport Zoning Commission (KACZ) and the FAA Determination of No Hazard in compliance the conditions of the Order.

4. Co-Applicants are submitting a Motion for Extension of Time to commence construction of the wireless communication facility for a period of nine months until April 12, 2026. This extension is to allow additional time to receive the Federal Communications Commission's Environmental Assessment coupled with the restrictions on approved months during which tree removal can be accomplished.
