**KIMBERLY-CLARK CORPORATION'S MOTION**  
**FOR CONFIDENTIAL TREATMENT**

1. Kimberly-Clark Corporation (“Kimberly-Clark”), by counsel, hereby moves the Kentucky Public Service Commission (“Commission”), pursuant to 807 KAR 5:001 Section 13, KRS 61.878, and other applicable law, to grant confidential treatment to the revised direct testimony and attachment that are the subject of Kimberly-Clark’s contemporaneously filed Motion to Revise Direct Testimony and Associated Exhibit Sponsored by Timothy Honadle.

2. The information for which Kimberly-Clark seeks confidential treatment is hereinafter referred to as the "Confidential Information." Because the Confidential Information is a slightly revised version of the Direct Testimony for which Kimberly-Clark sought confidential treatment on December 4, 2023, Kimberly-Clarke hereby adopts and incorporates its previous December 4, 2023 Motion for Confidential Treatment as if set forth herein, including the requested time period..

3. Based on the foregoing, the Confidential Information is entitled to confidential protection. If the Commission disagrees, then the Commission should hold an evidentiary hearing to protect Kimberly-Clark's due process rights and to supply the Commission with a complete record to enable it to reach a decision with regard to this matter. *See Util. Reg. Comm'n v. Ky. Water Serv. Co., Inc.*, 642 S.W.2d 591 (Ky. App. 1982).

WHEREFORE, Kimberly-Clark respectfully requests that the Commission classify and protect as confidential the Confidential Information.
