RESOLUTION NO. 09-2023

**A RESOLUTION OF HARDIN COUNTY WATER DISTRICT No. 1 ADJUSTING ITS WATER RATES TO OFFSET THE LOUISVILLE WATER COMPANY'S WHOLESALE RATE INCREASE**

**WHEREAS**, the Louisville Water Company ("LWC") supplies wholesale water to Hardin County Water District No. 1;

**WHEREAS**, Effective July 1, 2023, LWC's wholesale rate increased from \$2.55 per 1,000 gallons to \$2.63 per 1,000 gallons;

**WHEREAS**, based upon the water purchases from the LWC during the 12 month period from August 2022 to July 2023, the estimated annual increased cost to Hardin County Water District No. 1 will be \$46,379.04;


**WHEREAS**, KRS 278.015 and 807 KAR 5:068 provide for Hardin County Water District No. 1 to increase its water rates to adjust for the LWC wholesale rate increase via a Purchased Water Adjustment ("PWA").


NOW, THEREFORE, THE HARDIN COUNTY WATER DISTRICT No.1 BOARD OF COMMISSIONERS DOES HEREBY RESOLVE AS FOLLOWS:

- Section 1.** The facts, recitals, and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.
- Section 2.** The PWA factor is \$.04 per 1,000 gallons;
- Section 3.** All tiers of water usage and the wholesale water rate set forth in Hardin County Water District No. 1's existing tariff shall be increased by \$.04 per 1,000 gallons, subject to adjustments that may be made by the PSC.
- Section 4.** The monthly water rates to be charged to and collected from the customers and users of the water system of Hardin County Water District No.1 shall be as set forth in Exhibit C, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The rates set forth in Exhibit C are subject to adjustments that may be made by the PSC. These monthly rates shall be in effect for all water service rendered on and after October 1, 2023, upon PSC approval.
- Section 5.** The Chairman, General Manager, and Board attorneys are hereby authorized and directed to execute and file the PWA Application, Tariff Sheet, and all other documents that may be required by the PSC.
- Section 6.** This Resolution shall take effect upon its adoption.


