## APPLICANTS' SUPPLEMENTAL RESPONSE TO COMMISSION STAFF'S DATA REQUEST

New Cingular Wireless PCS, LLC, a Delaware limited liability company, d/b/a AT&T Mobility and VB 500 II, LLC, a Delaware limited liability company ("Applicants"), by counsel, make this Supplemental Response to the Kentucky Public Service Commission Staff's ("Commission Staff") First Request for Information to New Cingular Wireless PCS, LLC d/b/a AT&T Mobility and VB 500 II, LLC dated October 3, 2023. The aforesaid filing supplements Applicants' Response to Commission Staff's First Request for Information dated October 27, 2023 ("October 27, 2023 Response"). Applicants respectfully state, as follows:

1. When the October 27, 2023 Response was filed, Applicants had not received signed green cards or undelivered notice letters for the Landowners of Parcel # 51-83 (J

- & A Investments LLC) and Parcel # 52-15 (Michael D & Julie L Lake). Applicants re-sent notice to both landowners at the addresses listed on the PVA records for their respective properties (see Exhibit J-1 of the October 27, 2023 Response). Additionally, while preparing the October 27, 2023 Response, Applicants identified an entity listed on the Kentucky Secretary of State website as "J & A Investments LLC" (see footnote 2 of the October 27, 2023 Response). Although the registered agent's address matched the address listed on the relevant PVA records, the Secretary's information listed a separate address for that entity's Principal Office. Accordingly, Applicants also sent a copy of the notice to J & A Investments LLC's Principal Office.
- 2. Applicants received the returned signed green card for the notice letter that was re-sent to Michael D & Julie L Lake, landowners of Parcel # 52-15. Applicants also received the returned signed green card for the notice letter that was sent to the Principal Office of J & A Investments LLC, landowner of Parcel # 51-83. Copies of both returned signed green cards are attached as **Exhibit J-3**.
- 3. An Affidavit certifying that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry has been signed by the attorney supervising the preparation of the response on behalf of Applicants' and is included as **Exhibit 1**.

WHEREFORE, there being no ground for denial of the subject application and substantial evidence in support of the requested CPCN, Applicants respectfully request the Kentucky Public Service Commission:

- (a) Accept this Response for filing;
- (b) Issue a Certificate of Public Convenience and Necessity to construct and operate the WCF at the location set forth herein without further delay; and
- (c) Grant Applicants any other relief to which they are entitled.
