2. On September 30, 2023, the Customer Notice attached hereto and made a part hereof was mailed to all customers of the District along with their water bills.



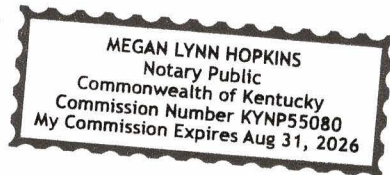

Notice is hereby given that the Cunningham Water District expects to file an application on or about October 4, 2023, with the Kentucky Public Service Commission seeking approval of a proposed adjustment to its water rates. The proposed rates shall not become effective until the Public Service Commission has issued an order approving these rates.

If the Public Service Commission approves the proposed rates, then the Phase 1 monthly water bill for a customer using an average of 4,000 gallons per month will increase from \$24.66 to \$30.74. This is an increase of \$6.08 or 24.7%. If the proposed rates are approved, then the Phase 2 monthly water bill for a customer using an average of 4,000 gallons per month will increase from \$30.74 to \$36.81. This is an increase of \$6.07 or 19.7%. It is proposed that Phase 2 rates be implemented one year after the effective date of Phase 1 rates.

The rates contained in this notice are the rates proposed by Cunningham Water District. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates shown in this notice.

Cunningham Water District has available for inspection at its office the application which it submitted to the Public Service Commission. A person may examine this application at Cunningham Water District's office located at 7506 US Hwy. 62, Cunningham, KY 42035. You may contact the office at 270-642-2287.

A person may also examine the application at the Public Service Commission's offices located at 211 Sower Boulevard, Frankfort, Kentucky, 40601, Monday through Friday, 8:00 a.m. to 4:30 p.m., or through the Public Service Commission's website at <http://psc.ky.gov>. Comments regarding the application may be submitted to the Public Service Commission through its website or by mail to Public Service Commission, PO Box 615, Frankfort, Kentucky, 40602. You may contact the Public Service Commission at 502-564-3940.

A person may submit a timely written request for intervention to the Public Service Commission, PO Box 615, Frankfort, KY, 40602, establishing the grounds for the request including the status and interest of the party. If the Public Service Commission does not receive a written request for intervention within thirty (30) days of the initial publication of this notice, the Public Service Commission may take final action on the application.
