**NOTICE OF FILING OF MONTHLY WATER SURCHARGE
ACTIVITY REPORT**

Comes now the Harrison County Water Association, Inc., by and through their counsel, Mr. Jesse P. Melcher, Esq., attested to by manger, Nathan Fields, and hereby files the monthly water surcharge report for the month of July, 2026 and initial billing information for the month of August, which encompasses the reading period of June 13, 2025 to July 12, 2026 (August 2026, Billing), as follows:

- A. See Attached spreadsheet of surcharge activity for the months beginning in February, 2024 (first billing, billed in March, 2024) to July 31, 2026 (billed in August, due August 15, 2026).
- B. The total amount collected for timely paid bills from February, 2024 to July 31, 2026, is \$245,881.36 including late paid bills, and with monthly interest of (previously earned interest, \$16.25, 2024), \$43.93 (for 2025) and \$41.83 (2026) {total interest \$102.01.
- C. The amount deposited for the month of July, 2026, was \$7,933.64, **see attached bank statement with deposit.**
- D. **The total amount of bills that were billed the \$1.43 surcharge across all five (5) meter classes for the month of July (July Billing) was 6434 bills for the total billed amount of $(6434 \times \$1.43) = \9200.62 .**
- E. HCWA has begun using a new excel spreadsheet in 2025, that can show more than one year and has only the same information as the KY PSC form being used.
- F. KY PSC authorized on 4-4-25 by Order herein, disbursement of \$63,341.36 and \$3,763.38 for payment and/or reimbursement of requested expenses out of the water surcharge account. *See Order.* The total disbursed was \$67,104.74; Further, KY PSC authorized on 4-4-25 by Order herein, disbursement of \$63,341.36 and \$3,763.38 for payment and/or reimbursement of requested expenses out of the

water surcharge account. *See Order.*; TOTAL AUTHORIZED DISBURSEMENTS OF \$72,035.91

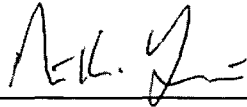
- G. All collected surcharge monies will be deposited into a separate account at Field and Main Bank, Cynthiana, KY, accounting ending in 12, under the name of Harrison County Water Association, Inc., wherein, the account was started with \$100.00 of contribution from Harrison County Water Association, Inc. (See. attached statement of account; \$100.00 was ultimately reimbursed back to O & M account). The water surcharge account has collected a total of \$245,881.36 in monthly surcharge fees, and \$102.01 in interest for 2024, 2025 and 2026 to date, total of \$245,983.37, and \$72,035.91 was disbursed as stated in alphabetical paragraph F above, and after disbursement (\$245,983.37- \$72,035.91=\$173,947.46); currently the account has \$173,947.46 as current balance, which correlates with the totals of receipted timely paid and late paid bills through July 31, 2026 minus authorized disbursements.

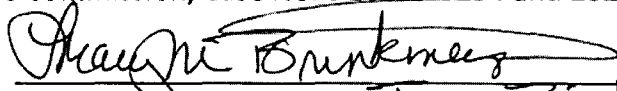

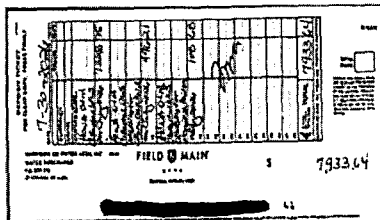
