MOTION FOR DECISION

FRON bn, LLC (the “Applicant” or "Frontier Solar”), by and through counsel, hereby submits this Motion for Decision and respectfully requests a decision by the Siting Board **no later than February 16, 2026 in light of the project’s anticipated construction commencement date of March 1, 2026**. In support of this motion, Frontier Solar states as follows:

On December 28, 2023, Frontier Solar filed an application with the Kentucky State Board on Electric Generation and Transmission Siting (“Siting Board” or “Board”) for a construction certificate to construct an approximately 120 megawatt (MW) merchant electric generating facility and a nonregulated electric transmission line in Marion and Washington Counties, Kentucky (the “Project”). On June 25, 2024, the Siting Board approved the requested certificate to construct the Project. As part of the construction certificate, the Board required Frontier Solar to comply with certain mitigation measures. Among the mitigation measures included in Appendix A to the construction certificate is Mitigation Measure No. 35 which provides as follows:

35. Frontier Solar shall adhere to the proposed transmission route presented in the application. Should Frontier Solar find it necessary to include any parcel of land not included in this response in order to finalize the route of the proposed transmission line, Frontier Solar shall return to the Siting Board to request an amendment to the location of the transmission line.

On July 2, 2025, Frontier Solar submitted a motion and related exhibits to amend its transmission line route pursuant to Mitigation Measure No. 35.¹ Therein, Frontier Solar requested the Board to approve amendments to the descriptions of the transmission line and route to include Parcel 063-015. To date, the Siting Board has not ruled on the motion to amend the transmission line and route descriptions.

Frontier Solar is nearing the end of the development phase and the Applicant is finalizing its contracts to commence construction of the Project, which is anticipated to begin on March 1, 2026. However, certain mitigation measures pending with the Siting Board cannot be satisfied without approval of the requested transmission line amendments, specifically Mitigation Measure Nos. 1 and 36, which require Frontier Solar to submit final site designs for its facility and transmission line.

In order to evaluate the Siting Board's ultimate decision and make any necessary design changes prior to filing the final layouts in preparation for the Project's March 1, 2026 construction commencement date, Frontier Solar respectfully requests a decision by the Siting Board no later than February 16, 2026.
