**GGSO, LLC'S NOTICE OF INTENT**

Comes now GGSO, LLC, by and through counsel, pursuant to KRS 278.700, et seq., 807 KAR 5:110, Section 2 and other applicable law, and does hereby tender its Notice of Intent to file an application, on or before December 29, 2023, for a Certificate to Construct an approximately 240 megawatt (“MW”) merchant solar electric generating facility in Ballard County, Kentucky (the “Gage Solar Project” or “Project”), respectfully stating as follows:

1. Pursuant to 807 KAR 5:110, Section 2(2)(a), the forthcoming application will be filed by GGSO, LLC, 13123 E Emerald Coast Parkway, Inlet Beach, FL 32461. The applicant’s telephone number is: (463) 210-9641 and its email address is: tyler@brightnightpower.com.
2. Pursuant to 807 KAR 5:110, Section 2(2)(b), the Gage Solar Project will be capable of generating approximately 240 MW of electricity from a solar array covering a total of approximately 2,017 acres. The Project will connect to a substation to be constructed onsite.
3. Pursuant to 807 KAR 5:110, Section 2(2)(c), the Gage Solar Project is located in unincorporated Ballard County, Kentucky, near the City of Kevil. The Project has a street address of 2972 Gage Road, Kevil, Kentucky 42053.

4. Pursuant to 807 KAR 5:110, Section 2(2)(d), there is no planning or zoning commission with jurisdiction over the site.

5. Pursuant to 807 KAR 5:110, Section 2(2)(e), there are no local setback requirements applicable to this site.

6. Pursuant to KRS 278.704(4), the applicant will request a deviation from the setback requirements found in KRS 278.704(2).
