STATUS REPORT

GGSO, LLC (“Applicant” or “Gage Solar”), by and through counsel, hereby provides this Status Report to the Kentucky State Board on Electric Generation and Transmission Siting (“Siting Board” or “Board”) in response to the Board’s letter dated February 10, 2026, with respect to above-captioned matter.

On November 15, 2023, the Applicant submitted its Notice of Intent and Election with the Siting Board, receiving case number 2023-00369 in connection with its anticipated application. On November 20, 2023, Gage Solar submitted its Notice of Intent (NOI) to file an application for a Certificate of Construction for an approximately 240 megawatt (MW) merchant solar electric generating facility in Ballard County, Kentucky (the “Project”). The Applicant tendered its Renewed and Restated Notice of Intent (“Renewed NOI”) on August 15, 2024, thereby renewing the prior NOI for the Ballard County solar facility.

Gage Solar hereby reports that the Project remains active and is in the process of optimizing its site plan in light of ongoing site-control efforts. The Applicant anticipates retaining the Project’s utility-scale generation capacity while filing a site plan that reflects a more contiguous

layout. Gage Solar intends to file a renewed NOI once the site plan is optimized and respectfully requests the Board retain the case number originally assigned to the Project.
