NOTICE REGARDING MOTION TO INTERVENE**

Comes now the Kentucky Solar Industries Association, Inc. (KYSEIA), by and through counsel, and provides this Notice concerning its Motion to Intervene. KYSEIA states the following.

In its Motion to Intervene, KYSEIA identifies Solar by Ecos LLC as a member of KYSEIA and as an entity taking service under Louisville Gas and Electric Company's ("LG&E") net metering tariff. The statement in the pleading is not correct. Although there are members of Solar by Ecos LLC who are currently or plan to be net metering customers of LG&E, Solar by Ecos LLC is not, itself, a net metering customer of LG&E. To this end, Solar by Ecos LLC is no longer an entity relied upon by KYSEIA in support of the Motion to Intervene. KYSEIA apologizes to the Commission and the parties for this error.
