On a motion made by Terri Thomas duly seconded by David Iery with all members voting yes to approve the **claims**, for all fund as presented. See Finance Book #11.


On a motion made by Terri Thomas duly seconded by Woody Underwood with all members voting yes to approve the **claim**, for the Fencing at the Garrison Playground.
