Due to the powerful winter storm forecast to impact Kentucky and southern Indiana Thursday into the Christmas holiday weekend. Minor snow accumulations appear likely Thursday night through Friday, and a rapid drop in temperature and high winds will likely worsen the impact of the any snow accumulations. Wind gusts late Thursday night through Friday could be in the 40-50 mph range. These winds along with the frigid temperatures will result in dangerous wind chills. The cold weather will last through Christmas.

LG&E/KU will enter into a Cold Weather Alert for the LG&E/KU service territory from 1200 EST on 12/22/2022 thru 1200 EST on 12/26/2022.
