Comments from Citizens – Several Otter Lake Loop residents addressed the court concerning the dam lawsuit and working toward a resolution. Scott Basham said he believed the county assumed

responsibility for the dam when it took the road in to county maintenance. Basham also questioned the state's determination that the dam valve was non-functional, and presented a video that he claimed was taken a day prior when he turned the valve on and off himself. Ron Segebarth reported that after attending a residents meeting with local officials at the Government Center, the neighbors' consensus is a willingness to share some of the repair cost and all have a desire to stay informed during the process. Garland Collins voiced his concern that the neighborhood is now a beautiful place and it would be an eyesore if the lake were ultimately drained. Mark Gilruth gave his opinion that he disagreed with the state's reported rain totals for the area. Judge Whitfield and County Attorney Lee Riddle said they would not comment on the specific case as it was in currently in litigation. County Engineer Frank Wallace explained the valve isn't the largest problem, but rather the installation of a newer valve and replacing pipe now that the state requires new valves to be located on the inside of a lake.
