**MORGAN COUNTY WATER DISTRICT’S  
MOTION FOR DEVIATION**

---

Comes Morgan County Water District (“Morgan District”), by and through counsel, pursuant to 807 KAR 5:001, Section 22 and other applicable law, and moves the Kentucky Public Service Commission (“Commission”) to grant a deviation from its July 26, 2024 Order granting Morgan District’s motion for emergency rates and authorizing Morgan District to place into effect an interim base rate increase, subject to refund, for service rendered on and after July 26, 2024.<sup>1</sup> As ground for its motion, Morgan District respectfully requests the Commission grant Morgan District authorization to place into effect the interim base rate increase, subject to refund for service rendered on and after August 16, 2024 because Morgan District is unable to prorate the bills with its current billing system. August 16, 2024 is the first date that Morgan District could apply the emergency rate to a full billing period and Morgan District is restricted by the limits of its billing system. In addition, in the event refunds are ordered by the Commission, implementing the interim rates for a full billing cycle would simplify the refund calculations for Morgan District.

**WHEREFORE**, Morgan District respectfully requests that the Commission grant this deviation from its July 26, 2024 Order, and authorize Morgan District to place into effect the




