Jackson Purchase respectfully states as follows:

The Commission's February 2, 2024 Order set forth the procedural schedule for the proceedings. There are no intervenors in this proceeding. Commission Staff issued requests for information on March 11, 2024. Jackson Purchase provided responses to the requests for information on March 25, 2024. Commission Staff issued supplemental requests for information on April 4, 2024. Jackson Purchase is providing its supplemental responses contemporaneously with this motion. The February 2, 2024 Order allows Jackson Purchase to request or waive a hearing on or before April 29, 2024. Jackson Purchase believes a robust and complete record has been developed through the Application, testimony contained in the Application, and responses to requests for information.
