At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, March 15, 2022, at 8:30 AM

Present: Honorable Mason Barnes, Judge/Executive Honorable Marty Chandler, East Magistrate Honorable Nathaniel Downey, West Magistrate Honorable Scott Poston, North Magistrate Honorable Myron Thurman, South Magistrate Honorable Sam Phillips, County Attorney Nicole Law, Treasurer Pam Rohrs, Fiscal Court Clerk

County Judge Executive Mason Barnes called the fiscal court meeting to order and Magistrate Downey opened with prayer followed by the pledge to the American flag.

Charter Communications Manager of State Government Affairs Carla Sandusky attended at the request of Fiscal Court to provide an update on the progress of the installation of cable for rural broadband as well as to be made aware of the problems that their installation crew has left behind. While residents in the north and northwest sections of Simpson County welcome fiber to their area, most are displeased with the way installers have left piles of rock and dirt on their property and, particularly, across driveways. Ms. Sandusky reported that Charter is in the first phase of installing the cable for approximately 220 miles in Simpson County providing this service to 1,784 homes. At this point installation of cable for the broadband which can also provide cable tv and phone service has been laid for twenty-one miles and 196 homes. Apparently, due diligence has not been exercised in notifying residents of plans of the installation process and there have been completels of inconsistences in the depth and distance from the road in various situations. Ms. Sandusky assured the court that she would see that the problems that had been brought up at this meeting will be submitted to Brandon Eaton, the installation manager for this area, and that as weather permits Charter will satisfactorily restore their properties to the way they were found.

Gilbert Mischel, Field Representative for U.S. Senator Mitch McConnell, gave a report from federal legislative action that has provided money to Kentucky for areas such as air service, workers for environmental cleanup, US Department of Agriculture and large amounts of funding for FEMA addressing natural disasters. Specifically for Simpson County some money will be available for the sixty-five identified orphaned cit wells. Magistrate Poston asked him about the USDA office and the possibility of it eventually being closed which would render the Simpson County Soll Conservation office homeless. Mr. Mischel will follow-up on this concern.

He also reported that Park's Director Lisa Deavers is in the process of applying for a \$250,000 Grant for a walking trail at the community park. Governor Andy Beshear will be in Franklin Friday, February 24th for the Trader Joe's Distribution Center groundbreaking at 11:00 AM and then following up at the Boys and Girts Club for check presentations for several agencies in Simpson County.

Magistrate Burr reported that his Facilities Committee met a couple of weeks ago with Maintenance Supervisor Rohrs presenting needs for the Historic Courthouse such as windows replacement and some general repairs and Kim Roberts with Renaissance wants improvements and repairs for courtyard dance floors and bandstand. County Clerk Austin Johnson discussed with this committee his opinions regarding the needs for the county clerk's facility.

Marty Chandler reported that his Equipment Committee met this morning and that they discussed with Public Works Director Groves who has been looking into purchasing a boom mower, specifically MowerMax Boom Mower with two heads. Magistrate Chandler's opinion was that while this purchase will be more expensive than a tractor and mower, the life of this equipment is significantly longer and he recommended the purchase. Director Groves reported that he already has some attachments that will work with this equipment.
