

# LEGAL NOTICE

## SIMPSON COUNTY WATER DISTRICT CUSTOMER NOTICE

NOTICE IS HEREBY GIVEN THAT THE SIMPSON COUNTY WATER DISTRICT WILL FILE AN APPLICATION WITH THE KENTUCKY PUBLIC SERVICE COMMISSION ON OR ABOUT MARCH 24, 2024, SEEKING APPROVAL OF A PROPOSED ADJUSTMENT TO ITS WATER RATES. THE PROPOSED RATES SHALL NOT BECOME EFFECTIVE UNTIL THE PUBLIC SERVICE COMMISSION HAS ISSUED AN ORDER APPROVING THESE RATES.

SIMPSON COUNTY WATER DISTRICT IS PROPOSING TO INCREASE ITS WATER RATES BY 5.81 PERCENT. THE PROPOSED RATES ARE CONTAINED IN THE TABLE BELOW.
