**MOTION**

Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by and through counsel, pursuant to KRS 61.878, 807 KAR 5:001, Section 13 and other applicable law, and requests that the Kentucky Public Service Commission (“Commission”) schedule an informal conference and a hearing in the above-captioned proceeding, respectfully states as follows:

**PROCEDURAL BACKGROUND**

The Commission issued its Order establishing this case on April 19, 2024 and propounded data requests on May 14, 2024. EKPC filed responses to Commission Staff’s First Request for Information (Staff’s First Request) on May 29, 2024. The Commission Staff’s Second Request for Information (Staff’s Second Request) was issued June 10, 2024 and EKPC responded on June 26, 2024. The Commission Staff’s Third Request for Information (Staff’s Third Request) was issued on July 22, 2024 and responses were filed on August 2, 2024.

**MOTION FOR INFORMAL CONFERENCE**

Due to the complex issues in this proceeding, EKPC moves the Commission to schedule an informal conference to discuss the issues in this proceeding and other factors.<sup>1</sup> EKPC believes

that an Informal Conference in this matter will aid in the successful resolution of this matter and will allow the parties to determine what issues will be addressed at the hearing in this matter.


**MOTION TO SET A HEARING DATE**


