EAST KENTUCKY POWER COOPERATIVE, INC.'S MOTION TO SUBMIT

Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by counsel, pursuant to the June 6, 2024 Order of the Kentucky Public Service Commission ("Commission") and other applicable law, and requests to submit this matter for a decision based upon the existing administrative record without a formal evidentiary hearing and requests a decision on the matter by **September 19, 2024**. EKPC respectfully states as follows:

The Commission's June 6, 2024 Order set forth the procedural schedule for this matter. There are no intervenors in this proceeding. Commission Staff issued requests for information on June 21, 2024. EKPC provided responses to the requests for information on July 8, 2024. Commission Staff issued supplemental requests for information on July 22, 2024. EKPC provided its supplemental responses on August 5, 2024. The June 6, 2024 Order allows EKPC to request or waive a hearing on or before August 12, 2024. EKPC believes a robust and complete record has been developed through the Application, testimony contained in the Application, and responses to requests for information. The interests of administrative economy favor avoiding a formal hearing when it would be unlikely to result in the development of any additional facts and

EKPC is unaware of any contested issues or additional facts that would be developed at a formal hearing.

WEREFOR, on the basis of the foregoing, EKPC respectfully moves to submit this proceeding based upon the existing administrative record. EKPC respectfully request a decision on this matter on or before **September 19, 2024.**
