Kentucky Power Company's Notice of Filing Updated Estimated Proposed DSM Rate

Kentucky Power Company ("Kentucky Power" or "Company") hereby files with the Public Service Commission of Kentucky ("Commission"), Supplemental Exhibit SEB-2 to the Direct Testimony of Scott E. Bishop, which is comprised of an update to the estimated demandside management ("DSM") rates that would result from the Company's proposals in this case, based on actuals as of September 30, 2024. Although the Commission's November 22, 2024 Order absolved the Company of the requirement to make the annual DSM filing that would have produced the updated estimated rates, the Company is nonetheless providing the updated estimated rates in this proceeding as a result of collaboration with the Joint Intervenors.

In summary, Supplemental Exhibit SEB-2 demonstrates that the residential DSM rate is estimated to be \$0.000587, as compared to \$0.000644 in the Company's initial filing, and the commercial DSM rate is estimated to be \$0.000573, as compared to \$0.000565 in the Company's initial filing.

If the Company's proposals in this case are approved, the Company would again update the DSM rates based on the most-recent available actuals after the Commission's final order is issued and would provide that rate with its compliance tariff.
