**MOTION FOR DEVIATION FROM 807 KAR 5:011, SECTION 8(2)**

Pursuant to 807 KAR 5:001, Section 5(1) and 807 KAR 5:011, Section 15, Ohio County Water District (“Ohio District” or “the District”) moves for leave to deviate from 807 KAR 5:011, Section 8(2) to publish notice of its proposed tariff revisions in a manner that differs from the requirements of that regulation.

In support of its motion, the District states:

1. The District’s full name and mailing address are: Ohio County Water District, 124 East Washington Street, Hartford, Kentucky 42347. Its electronic mailing address is: ehickman@ocwdky.org.
2. The District is neither a corporation, limited liability company or a partnership, but is a water district organized pursuant to KRS Chapter 74.
3. Pursuant to KRS 278.015 and KRS 278.040, the District’ rates and conditions of service are subject to the regulation of the Public Service Commission.
4. On April 1, 2024, pursuant to KRS 278.180 and 807 KAR 5:011, the District filed with the Public Service Commission proposed revisions to its existing rate schedules and rules and regulations and proposed to make these revisions effective on May 1, 2024. The Public Service Commission docketed this tariff filing in its electronic filing system as Tariff TFS2024-00151.

5. 807 KAR 5:011, Section 8(2) requires the District to provide its customers notice of the proposed tariff revisions. Section 8(2)(b)1 permits the District to provide such notice by “[p]ublishing notice once a week for three (3) consecutive weeks in a prominent manner in a newspaper of general circulation in the utility’s service area, the first publication to be made no later than the date the tariff filing is submitted.”

6. The District provides service to the following counties: Ohio County (5,578 customers), Grayson County (16 customers), Breckinridge County (133 customers), and Daviess County (508 customers).<sup>1</sup> The newspapers of general circulation in these counties are: *Ohio County Times News*, *Grayson County News*, *The Breckinridge Herald-News*, and *Messenger-Inquirer*.

7. To comply with the requirements of 807 KAR 5:011, Section 8(2), the District contacted the newspaper of general circulation in each county by email and requested publication of the notice attached as Exhibit A to this Motion once weekly for three consecutive weeks beginning no later than April 1, 2024.

8. Notice was successfully published in the *Messenger-Inquirer* and the *Ohio County Times News* on March 27, April 3, and April 10, 2024. See Exhibits B and C to this Motion.

9. Because of a miscommunication between the District and the publisher of *Grayson County News*, notice in that publication did not appear until April 6, 2024 and was published again on April 13 and April 20, 2024. See Exhibit D.

10. As of this date, notice of publication has not been published in *The Breckinridge Herald-News*. Prior to filing its revised tariff, the District made several requests by email and voicemail for publication of its notice of filing in that newspaper. When preparing to file evidence

of publication in all newspapers, representatives of the publication advised that ownership of the publication had changed and that the requests for publication had not been acted upon. The District has made arrangements for publication of a revised notice to appear notice had not been published. appear in the May 1, May 8 and May 15 editions of *The Breckinridge Herald-News*. A copy of the revised notice is attached as Exhibit E to this Motion. The District will file an affidavit of publication and tear sheets for the revised notice as soon they become available.


11. The District requests a deviation from 807 KAR 5:011, Section 8(2) to permit its proposed revised tariff be considered filed as of May 1, 2024 with a revised effective day of June 1, 2024. All District customers will have received initial notice of the proposed tariff revisions as of that day and all will have 30 days from that date to submit comments or objections to the proposed tariff revisions or requests for intervention.

12. The District has acted in good faith and in a reasonable manner to ensure compliance with 807 KAR 5:011, Section 8(2) and its requested deviation is consistent with the regulation's intent and spirit.

WHEREFORE, the District requests that the Public Service Commission issue an Order granting the requested deviation from 807 KAR 5:011, Section 8(2) and finding that the District's proposed tariff revisions are filed as of May 1, 2024 and may be placed into effect on June 1, 2024 unless the Public Service Commission, pursuant to KRS 278.190, suspends their operation.

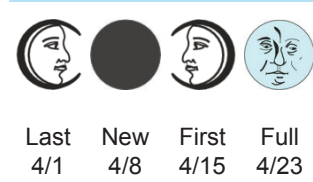

# Trump's social media company gains in 1st day of trading

NEW YORK — Shares of Donald Trump's social media company rose about 16% in the first day of trading on the Nasdaq, boosting the value of Trump's large stake in the company as well as the smaller holdings of fans who purchased shares as a show of support for the former president.

Trump Media & Technology Group Corp. merged Monday with a blank-check company called Digital World Acquisition Corp. Trump Media, which runs the social media platform Truth Social, has now taken Digital World's place on the Nasdaq stock exchange.

Shares closed at \$57.99, up 16.1%, giving the company a market value of \$7.85 billion. At one point the stock was up about 59%. Trump holds a nearly 60% ownership stake in the company, now worth about \$4.6 billion.

Many of those investing in Trump Media are small-

time investors either trying to support Trump or aiming to cash in on the mania, instead of big institutional and professional investors. Those shareholders helped the stock of Digital World more than double this year in anticipation of the merger going through.

Truth Social launched in February 2022, one year after Trump was banned from major social platforms including Facebook and X, formerly Twitter, following the Jan. 6 insurrection at the U.S. Capitol. He's since been reinstated to both but has stuck with Truth Social.

On Truth Social Tuesday, users were posting about being shareholders or seeking tips on how to buy shares.

One user urged conservatives to "get behind the DJT stock and sent it over \$100 per share" to "drive the liberals insane!" Another declared: "Get yourself a piece of #DJT stock if your a true MAGA supporter."

A day earlier, Trump Media CEO Devin Nunes, a former House Republican, said, "As a public company, we will passionately pursue our vision to build a movement to reclaim the Internet from Big Tech censors."

Despite the enthusiasm, investors could experience a bumpy ride. For one, they're betting on a company with uncertain prospects of turning a profit. Trump Media lost \$49 million in the first nine months of last year, when it brought in just \$3.4 million in revenue and had to pay \$37.7 million in interest expenses.

In a recent regulatory filing, the company cited the high rate of failure for new social media platforms, as well as its expectation that its operations will lose "for the foreseeable future" as risks for investors.

Research firm Similarweb estimates that Truth Social had roughly 5 mil-

lion active mobile and web users in February. That's far below TikTok's more than 2 billion and Facebook's 3 billion — but still higher than other "alt-tech" rivals like Parler.

However, Trump Media has said it doesn't keep track of some numbers that rivals use as key measures of their performance, such as average revenue per user or active user accounts. It says it wants

to focus on the long-term instead of "short-term decision-making."

For that long term, though, skeptics see struggles ahead for a company that's estimated to have far fewer users than rivals in a business where gaining a critical mass is key.

"I think there is a possibility of, sooner or later, the stock price falling by 95%," said Jay Ritter, a professor and expert on initial

public offerings of stock at the University of Florida's Warrington College of Business.

Brian Dunn, director of the Institute for Compensation Studies at Cornell University, compared the fervor for Trump Media shares to the meme stock craze that boosted shares of companies such as GameStop and AMC Entertainment to exorbitant heights in 2021.

# Gray tosses 5 innings in Cards debut to help St. Louis defeat Philadelphia

ST. LOUIS Sonny Gray tossed five innings in his St. Louis debut, and the Cardinals shut out the Philadelphia Phillies 3-0 on Tuesday night.

Gray (1-0) allowed five hits, struck out five and walked none. The 34-year-old right-hander threw 43 of his 64 pitches for strikes.

Gray signed a \$75 million, three-year contract with St. Louis in free agency. He missed the start of the season after he hurt his right hamstring in a spring training game against Washington on March 4.

After Gray departed, Matthew Liberatore, Andrew Kittredge and JoJo Romero combined for three innings before Ryan Helsley handled the ninth for his fourth save in five chances this season.

Philadelphia right-hander Zack Wheeler (0-2) permitted three runs and six hits in seven innings. He struck out five and walked one.

## DODGERS 6, TWINS 3

MINNEAPOLIS — Tyler Glasnow tied his career high with 14 strikeouts in seven scoreless innings, and Los Angeles beat Minnesota.

James Outman and Will Smith each hit a three-run homer as Los Angeles won for the third time in four games. Mookie Betts walked three times and scored a run.

Glasnow (3-0) struck out Matt Wallner looking to end the seventh inning, marking the third time in his career he picked up 14 strikeouts. He also accomplished the feat for Tampa Bay last season against the Red Sox and in April 2021 against Texas.

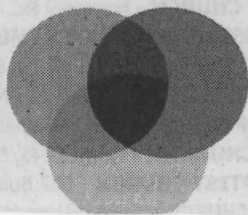

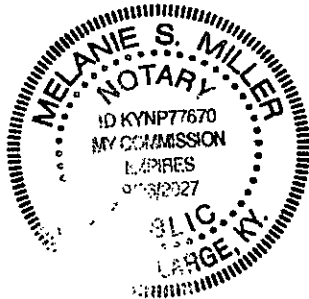

# Always on God's mind

Psalm 139, which is a meditation upon the omniscience and the omnipresence of God, is one of the greatest Psalms and can really lift us to new heights in our living. In the Psalm, man is seen as special because of his relationship to God.

God knows everything about us. Our acts: "When I sit down and when I rise up." Our thoughts: "understand my thoughts from afar." Our words: "before there is a word on my tongue, Thou dost know it." The Psalmist realized nothing about us was hidden from God, and he could not comprehend this; it blew his mind: You are "intimately acquainted with all my ways" (v.3).

God is everywhere, so there is no place he could go to escape God (v.7-12). All the wonderful things said about God in verses 1-12 is a prelude to the primary message in verse 13, "For Thou didst form my inward parts; Thou didst weave me in my mother's womb." God is seen as the Master Craftsman creating and putting us together in the womb. The result: We are "fearfully and wonderfully made" (v.14). The key truth is that God takes special interest in every person.

But the wonderful thought in verses 17 and 18 is that we are continually on the mind of God. God thinks about us day and night. God planned our lives from the beginning, and we are valuable to Him. That should boost how we think about ourselves. As someone said, "God don't make no junk." That should be enough right there to challenge us to noble living.

We are "fearfully and wonderfully made" (v.13). When God made us, He didn't use a cookie cutter. Nor were we the result of some giant assembly line, but we are each custom designed unlike anyone else. We are one of a kind. We say, "When they made him they threw away the mold." Beethoven had a hearing problem and was completely deaf by the age of 30. He was completely deaf when he wrote his Ninth Symphony. Abraham Lincoln had an inadequate education, and yet he became one of our greatest presidents. Thomas Edison, who invented so many products that bless us today, was almost deaf. He used his liability to help him concentrate even more on his work.

We all have handicaps and limitations, but we are "fearfully and wonderfully made." Don't go around complaining, but remember you are created by God and you should let Him use you in His service. The Psalmist said, long before you came into being, God had a plan for you, and one of your greatest joys is to find and fulfill God's plan.

Don't ever think of your life as meaningless. Our great challenge is to find and commit ourselves to God's plan for us.

The finest thing that can ever happen to us is to live just the way God planned. Jesus did that, and on the cross He said, "It is finished"

(John 19:30). He was not finished, but "it" was finished. The plan God had for Him even before He was "born in a manger." God wants to reveal His plan for us. We conclude with this thought from Psalm 139: We are always on His mind. The creator and sustainer of this vast universe keeps us on His mind.

How can anyone number the thoughts of God? But we are the focus of His continual thought. Though we are fearfully and wonderfully made, though God has a plan for us, and though we are continually on His

mind, we have a fatal flaw. We have sinned against God and are alienated from Him. Look at the prayer he prays in verses 23-24: "Search me, know me, lead me in the way everlasting."

Turn to Him, trust Jesus with your whole heart, and you can reach the plan God has for you. God loves you, for He said, "I am come that you may have life and have it more abundantly" (John 10:10). "For God so loved the world that He gave His only begotten Son..." (John 3:16). God wants to save and bless you and use you for His glory and the betterment of mankind. Pray the Psalmist prayer in verses 23-24... "Search me, know me,

lead me in the way everlasting."

## A good daily practice

A house without windows would not be very inviting. Windows serve two functions — they let light in from the outside, and they allow us to view the beauty of the outside world.

Dr. Elizabeth Kübler-Ross, an American-Swiss psychiatrist, a pioneer in near-death studies and author of the book *On Death and Dying*, has said, "People are like stained-glass windows. They sparkle and shine when the sun is out, but when the darkness sets in, their true beauty is revealed only if there is light from within."

In the Christian life, that light from within is Christ. Christ makes the difference. He is "the Light of the world." We are a reflected light. The Bible speaks of many windows. In Genesis 7:11, we read that God opened the flood-gates (windows) of heaven and sent the rains upon the earth. After 40 days, Noah opened the window of the ark and sent out the raven and later the dove to search for dry ground (Genesis 8:6).

Rahab placed the scarlet thread in her window for safety when Joshua's army overran the city, and she was saved along with her household (Joshua 2:15-18, 21). This suggests our eternal salvation and that we are safe behind the blood of Christ.

Daniel used his window three times a day as he opened it to pray to God (Daniel 6). In Malachi 3:10, God promises to open the windows of heaven and shower the faithful

tither with blessings from heaven. Paul was let down by friends through a window in the city wall, and he safely escaped from a mob that wanted to kill him. One night Paul was preaching, and a young man went to sleep and fell to his death from an upper window. Paul went down and revived him.

So the Bible tells us of many windows, but the main truth we need to get is that God opens the windows of heaven. God has opened the windows of heaven in the past, and one day He will open them again.

God opened the

windows of heaven and sent us a Savior. In Bethlehem, God sent His beloved Son to earth. Christ was born of a virgin. This was the way God chose. He could have sent Christ a full-grown man, but Jesus came as a tiny baby to grow up and face all the grief, heartaches and troubles of life and thus sympathize with us when these things come to us.

The windows of heaven were opened by God when He sent the Holy Spirit. When Jesus went away, He promised to send the Holy Spirit (John 14:26, 16:7). Today, the Holy Spirit is God, who operates in and abides in our hearts.

One day God will open the windows of heaven,

and Christ will come to earth again (Acts 1:11). His return will mean resurrection of those who have died in Christ (1 Thessalonians 4:16), reunion with the saints (verse 17), reward for our service (Revelation 22:12), rejoicing to be in heaven (Revelation 19:9), and reigning with Christ (1 Thessalonians 4:17).

There are some biblical words we use far too freely — and amazingly — too loosely. Testimony is one of those words. Many Christians define the word testimony too narrowly. Sharing Jesus is much more than just telling our story or talking about God's work in our lives,

although those things are important. We need to be prepared to meet unbelievers at the point of their spiritual need, even if our own story is very different. Each person coming toward God is not coming from the same background, they are not coming from the same bed of sin, nor from the same knowledge level about God.

We can learn a lot from Phillip's encounter

with the Ethiopian eunuch. While this young Israelite had friends and family to disciple him in his faith, a foreign convert often had to work alone to discern the meaning of the Scriptures. So, by asking, "Do you understand what you are reading?" Phillip was acknowledging that he understood the Ethiopian's disadvantage. That one question enabled him to discover that the man had a genuine thirst for God's truth but did not know of the Messiah.

Phillip used that information to tailor fit a gospel testimony for this Ethiopian listener.

Consider how easily the man could have become confused or frustrated if Phillip—whose Jewish background was so different from the Ethiopian's—had told only his own conversion story. Phillip wisely relied on the text at hand and allowed the power of God's Word to introduce the man to Jesus Christ. Remember, the gospel is "the power of God to salvation."

Phillip's testimony began with the passage the Ethiopian was reading. He effectively spoke to the man's spiritual interest in general terms while specifically answering his questions about Isaiah 53. We, too, must be sensitive to unbelievers' concerns so we can explain how God will meet their needs.
