The meeting opened in Prayer by Commissioner Castlen and the Pledge of Allegiance to the Flag.

Judge Castlen Proclaimed May 2023 as High School Heroes (HSH) Month and along with Vicki Ellis, Director of Communications, Development, and Recruitment for the Western Kentucky Regional Blood Center recognized and expressed appreciation to the 2023 Graduating Class of HSH. She explained that HSH are graduating students who have donated blood four times or volunteered four hours (or a combination of both). She noted, Owensboro-Daviess County students, this school year, in total, donated 384 units (1,152 components) of blood and stated, "I am very proud of these guys."

Ms. Ellis called the following students by name and presented them certificates of recognition and red HSH graduation commencement cords, which she said symbolizes courage, willpower, and strength and should be worn during graduation ceremonies. She acknowledged, with great appreciation, two students who exceeded the HSH minimum requirement. Michael Lowe donated five times and Anthony Luna donated a gallon of blood.

On behalf of Judge Castlen, Commissioner Marksberry Proclaimed May 21-27, 2023, as Emergency Medical Services Week.

Owensboro Health EMS Program Coordinator James Paris thanked the court for the recognition. He stated, "I am proud to say that I work beside these individuals every day who are very dedicated in providing the emergency care that is needed. These individuals are the true heroes of our community."

### Judge Castlen thanked all First Responders.

Commissioner Conder pointed out that the family members of First Responders are also appreciated as they support their work, which is so important.

#### \*\*\*\*\*

Representing the Daviess County Alliance for Substance Abuse, Dr. RonSonlyn Clark presented information about drug addiction. She stated, "Our community does not have a drug problem, we have multiple drug problems. Most critical to us today is the use of methamphetamines and opiates, especially fentanyl. Approximately 69% of individuals entering treatment in Owensboro-Daviess County are there primarily for the treatment of methamphetamine. At the state level, that number is 55%. Second to the issue of meth in our community is marijuana, with a total of 64% entering treatment for marijuana. The third most used here in our area is alcohol at 42%, compared to 52% statewide. Lastly, and increasing every year, is the use of opiates and most importantly fentanyl. Opiates come in at around 35% of those who enter treatment. Methamphetamine and fentanyl, two drugs not made from plants but from chemicals are defining the new drug world and have formed an unmercifully addictive, mind-altering deadly concoction. As we navigate into the third decade of the meth epidemic, we have learned meth is not going away and we have now developed a twin epidemic of meth users also using opiates. The meth we see today in our community is not the meth of old. What we currently see is no longer made with cold medications. Individuals are not in the woods cooking meth in dangerous situations or riding around the bypass with one pot labs. The meth today is made from a variety of legal and available substances in Mexico. It is then illegally imported into the United States where it is often cut with other substances. This new meth has been around us for about 10 years. Today's meth is more powerful and has greater purity. It puts more people into deeper levels of mental illness and homelessness. More people are going to jail and having serious physical health issues. The price of meth is low. However, for the dealer, the price can be doubled if you cut it with fentanyl. We are entering the world of synthetic drugs. A few drugs, except for marijuana, will be grown. Growing requires land, cultivating, rain, a growing season, workers in the field. Synthetic drugs require chemicals and a warehouse to manufacture day and night, year-round. It makes economic sense to manufacture thousands of pills a night compared to a single harvest of a crop. Fentanyl is an immensely popular drug. Ninety percent or more of our drugs today are laced with fentanyl. It is easy to manufacture and smuggle. It is cheap and highly addictive. It is such an enticement that dealers do not, dare not mix it in. Users will come to a dealer who puts fentanyl in their drugs. If you put fentanyl in other drugs, then you will create a new opiate user who will need to buy it daily. One may need to buy meth 1 or 2 times a week. Putting fentanyl in it means you need to buy it 2-3 times a day. In the drug world, an overdose is an advertisement that this drug is very good. Many unsuspecting users do not even know there is fentanyl in the drug they are using. Today, I tell people, if you're going to use, you need to assume it has fentanyl in it. Fentanyl changes everything. In 2021, there were more than 1,791 Kentuckians killed by accidental opioid overdoses. According to the office of drug control policy, over 1,500 of those deaths involved fentanyl. I have mentioned the top drugs in our community, let us not forget that we have plenty of cocaine, benzodiazepines, sedatives, psychedelics, hallucinogens, kratom, marijuana products, dangerous over-the-counter prescriptions, drugs put into Vape devices, smoked, ingested, snorted, and used intravenously, and alcohol - we always have alcohol. What do we know? We know substance use is a public health crisis. Those using opiates and methamphetamine have entered treatment at twice the rate in the last 10 years. Treatment is necessary to reduce their depression, anxiety, suicidal thoughts, and attempts, and family and societal violence. Treatment is necessary to reduce incarceration rates. It promotes employment and reduces the use of Social Services. For every \$1 spent on treatment, \$4.52 is returned to the community for services that are no longer needed. Communities must come together to re-examine ideas, customs, and policies, and become willing to innovate. Let us find ways to gather the local talent, leverage their energy, and expertise, and find a way to work together. We know we are better when we work together as a community. Community involvement is imperative to the recovering individual. You protect the community best by getting addicts into sobriety. Owensboro-Daviess County is a strong community, and we are blessed to have many services that offer care to the recovering individual with many levels of care, but we still need more. An important factor in the recovery process is the presence and involvement of people who believe it is the person's ability to recover. Persons who offer hope, support, and encouragement - who also offer and suggest strategies and resources for change. Owensboro-Daviess County, the challenge is now, and it is here. What can you as an individual or you as a member of a group do to help promote recovery? We are only as strong as our weakest individuals. Our best defense against the devastation drugs have done is to bolster community involvement. Addiction thrives in isolation. Recovery thrives in a strong community. People can and do recover. The challenges that lie before us are many. Thank you."

Judge Castlen stated, "I know the words you speak are filled with truth. I am disappointed, at some level, that all the folks that left a few minutes ago left. If I had had a clue what you were going to share with us, I would have asked them to please stay because I think the more people that hear the message you just shared, the better off our community will be. So, thank you."

Commissioner Conder asked Dr. Clark about opiate settlement fund recommendations.

Dr. Clark: The Alliance is looking at strategic planning and knows that from law enforcement, prevention, treatment, and recovery, the solutions must be intentional to be sustainable. She noted that the Alliance wants these settlement dollars to last not 15 years, but 50 to 60 years. She stated, "We are going at this very systematically to try to make the best decisions we can for the use of that money."

Commissioner Conder stated, "Time is of the essence, isn't it?"

Dr. Clark replied, "Yes."

The court expressed sincere appreciation for the work Dr. Clark does for those she serves.

\*In accordance with the provisions of KRS 67.045 and KRS Chapter 424, notice is given that the fiscal court plans to reapportion the boundary lines for the three Fiscal Court Commissioners, three Justices of the Peace, and three Constables. Boundary lines shall be laid off so that the districts are compact, contiguous, and the population of each district shall be as nearly equal as is reasonably possible. The fiscal court shall appoint three citizens as commissioners to reapportion the county into three (3) districts. The first meeting of the Reapportionment Committee is **June 8, 2023**, at 5:00 p.m. in the Daviess County Fiscal Court, Courtroom. A written report of such boundary lines shall be filed with the Daviess Fiscal Court and the Office of the County Clerk within 60 days of appointment of commissioners. Within 60 days of receipt of the report establishing the three districts, the fiscal court shall adopt or amend the report. As soon as the fiscal court adopts the report, any Daviess County registered voter may bring an action in Circuit Court to enforce the provisions of KRS 67.045. Any action brought to Circuit Court must be done within 20 days from fiscal court's adoption of said report. Circuit Court shall hear the action and, on a finding that provisions of KRS 67.045 have been violated, remand the matter to fiscal court.
