**OHIO COUNTY WATER DISTRICT**  
**STATEMENT AND MOTION FOR DEVIATION**

---

By and through the undersigned counsel and pursuant to 807 KAR 5:006, Section 28 and ordering paragraph six of the Commission’s December 22, 2025 Order in this proceeding, Ohio County Water District (“Ohio District”) submits its Statement detailing the amounts its customers were underbilled from March 2025 to November 2025 and its Motion for Deviation.

Filed separately as **Exhibit 1** is a spreadsheet providing, by account number, the total amount underbilled, the monthly amount to be billed to recover the underbilled amount over 11 months, and the monthly amount to be billed, rounded down to the nearest penny. Ohio District underbilled \$187,731.83 during the period in question. Ohio District serves approximately 6,200 customers and 2,897 were underbilled. A breakdown of the amounts to be recovered appears below.

Ohio District proposes to bill those customers who were underbilled a **total amount** of **\$1.00 or less** for the under-billed amount on the February 24, 2026 bill. For customers for whom the total under-billed amount is **over \$1.00**, Ohio District proposes to bill the customer an equal amount, as shown in **Exhibit 1**, over 11 months (bills mailed February 2026 through December 2026). A proposed tariff sheet setting forth this schedule is attached as **Exhibit 2**. The tariff sheet has also been filed using the Electronic Tariff Filing System.

Ohio District proposes to use the following language on its bills to distinguish the amounts being billed to recover the underbilling from the amounts being billed for current water service: Temporary Recovery Billing per PSC Order of December 22, 2025 in Case No. 2024-00127.

Because 807 KAR 5:006, Section 11(2)(e) provides that “[a] utility shall not require customer repayment of an underbilling to be made over a period shorter than a period coextensive with the underbilling,” Ohio District requests a deviation

pursuant to 807 KAR 5:006, Section 28 to permit it to issue one-time bills on February 24, 2026 to customers who were underbilled \$1.00 or less. This will prevent the unnecessary administrative burden of billing extremely small amounts on 11 separate billings. Because the total amount to be billed to any customer will not exceed \$1.00, the District does not expect this to present an unreasonable burden to its customers. Because **time is of the essence**, Ohio District requests the Commission issue a decision on this Motion as soon as possible.
