**NOTICE**

Comes now East Kentucky Power Cooperative, Inc., (“EKPC” or the Company”), by and through the undersigned counsel, pursuant to 807 KAR 5:001 and other applicable law, and hereby respectfully submits notice that it has distributed the amounts due to Owner-Members for the calendar years 2022 and 2023<sup>1</sup> pursuant to the Earnings Sharing Mechanism as contained in the Joint Stipulation and Settlement Agreement in the Kentucky Public Service Commission’s (“Commission”) Case No. 2021-00103, *In the Matter of: Electronic Application of East Kentucky Power Cooperative, Inc., for a General Adjustment of Rates, Approval of a Depreciation Study, Amortization of Certain Regulatory Assets and Other General Relief.*<sup>2</sup> In addition, Each of EKPC’s sixteen distribution cooperatives (“Owner-Members”) have distributed the amounts due to each of their end-use members. EKPC has filed the allocation of the amounts distributed to each of its Owner-Members. Each Owner-Member has also filed into the record of this proceeding the

Therefore, EKPC respectfully submits notice that EKPC and its Owner-Members have complied with the Commission's Orders in this matter and all required accounting of the distributions of the Earnings Sharing Mechanism has been filed into the record of this proceeding.

WHEREFORE, EKPC respectfully submits notice to the Commission that EKPC and its Owner-Members have distributed the 2022 and 2023 amounts pursuant to the Earnings Sharing Mechanism and all required accounting of same has been filed into the record, completing the required matters in this case and the case can now be closed and removed from the Commission's docket.
