## RESPONSE TO STAFF'S THIRD REQUEST FOR INFORMATION FOR CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY FOR CONSTRUCTION OF A WIRELESS COMMUNICATIONS FACILITY

Cellco Partnership, d/b/a Verizon Wireless and Horvath Towers VI, LLC ("Co-Applicants"), by counsel, pursuant to (i) KRS §§278.020, 278.040, 278.650, 278.665, and other statutory authority, and the rules and regulations applicable thereto, and (ii) the Telecommunications Act of 1996, respectfully submit this Application requesting issuance of a Certificate of Public Convenience and Necessity ("CPCN") from the Kentucky Public Service Commission ("PSC") to construct, maintain, and operate a Wireless Communications Facility ("WCF") to serve the customers of the Co-Applicant with wireless communications services.

In response to the Third Request for Information, Co-Applicants respectfully provide and state the following information:

1. Refer to the Geotechnical Report provided as Exhibit 1 to the Supplemental Information Post Order filed on November 26, 2024. Joseph V. Borrelli stamped and signed the report as a licensed engineer in Kentucky. Confirm Joseph V. Borrelli was actively licensed in Kentucky at the time of filing and provide the date

when the license expires. If not confirmed, explain how the application complied with the applicable regulations.

**Answer:** Joseph V. Borrelli was actively licensed with the Kentucky Board of Engineers and Land Surveyors on November 26, 2024, at the time of filing. The Kentucky Board of Engineers and Land Surveyors renewal requirements state all persons with Last Name A - K are required to renew their license every odd year by June 30 and Last Name L - Z every even year by June 30. Please see **Exhibit 1** attached indicating Mr. Borrelli's license is active and due for renewal on June 30, 2025.

signed and sealed the drawings.

persons with Last Name A - K are required to renew their license every odd year

attached indicating Mr. Schneider's license is due for renewal on June 30, 2026.
