Big Rivers Electric Corporation (“Big Rivers”) is electronically filing this letter, which constitutes the Read1st file required by 807 KAR 5:001 Section 8(5) and Big Rivers’ Witness List pursuant to Ordering Paragraph No. 4 of the Order dated April 8, 2025, in this matter.

The purpose of this letter is to notify the Public Service Commission (the “Commission”) that Terry Wright, Jr., Vice President of Energy Services, will no longer be employed by Big Rivers, as of May 8, 2025. Big Rivers’ CEO and President, Donald L. (“Don”) Gulley is being substituted as a witness with respect to the information request responses that Mr. Wright originally sponsored in the above referenced matter. Information filed in Case No. 2024-00141,¹ the fuel adjustment clause (“FAC”) review set for hearing on June 4, 2025, with the above referenced case. Both requests were identical.

Additionally, Katherine S. (“Katie”) Cheatham, Manager Accounting at Big Rivers, is being added as a supporting witness with respect to an information request response originally sponsored by Christopher A. Warren. Ms. Cheatham has adopted Mr. Warren’s response to Item 16 of the Commission Staff’s First Request for Information. Ms. Cheatham assisted in preparing the attachment to Big Rivers’ response to Item 16. Mr. Warren will remain the sponsor for all responses that he originally sponsored.

Ms. Cheatham began her employment at Big Rivers in April 2015, and has held her current position since March 2019. Prior to her current position, she worked as a budget analyst for Sebree Station at Big Rivers. As Manager Accounting, she is responsible for managing financial reporting, fuels accounting, and fixed asset accounting. She earned both a Master of Science in Accounting and Bachelor of Science in Accounting from the University of Kentucky in 2007 and 2006, respectively. Ms. Cheatham also holds a certified public accountant (CPA) license.
