MOTION FOR INFORMAL CONFERENCE

Navitas KY NG, LLC (“Navitas”), by counsel, hereby moves the Kentucky Public Service Commission (the “Commission”) to schedule an informal conference in order to discuss the status of its above-referenced Purchased Gas Adjustment Filing cases currently pending before the Commission, and to facilitate the resolution of any outstanding issues in these cases.¹

Commission regulations authorize any party to a Public Service Commission case to request that the Commission convene a conference “for the purpose of considering the possibility of settlement, the simplification or clarification of issues, or any other matter that may aid in the handling and disposition of the case.”² Navitas believes that an informal conference would promote the swift resolution of its outstanding cases, and provide insight into what steps Navitas may take to resolve any issues that exist in these cases.

For the foregoing reasons, Navitas respectfully requests that the Commission schedule an informal conference as soon as possible to discuss the status of its Purchased Gas Adjustment
