**RESPONSE TO NOTICE OF FILING DEFICIENCY**

Applicant, by counsel and in response to the Kentucky Public Service Commission's ("PSC") letter dated August 12, 2024 requesting additional information to cure a deficiency in the within matter, states as follows:

1. In Response to the PSC's finding of a deficiency with respect to 807 KAR 5:063 Section 1(1)(k), Applicant hereby submits the map attached as **Exhibit A**.
2. In Response to the PSC's finding of a deficiency with respect to 807 KAR 5:063 Section 1(1)(l)(1) and (n)(1), Applicant re-sent notice to the landowners listed in Exhibit J of the filed application and the County Judge Executive on August 12, 2024. The revised letters reference a total structure of 255'.
3. A copy of the revised letter (with the applicable enclosure) sent to landowners on August 12, 2024 has been attached as **Exhibit B**.
4. The notice list attached as Exhibit J of the filed application was reviewed by a representative of the Metcalfe County Property Valuation Office on August 12, 2024.

The accuracy of the list was confirmed via email and a copy of that email is attached as **Exhibit C**.

5. Seventeen notice letters were sent to landowners on August 12, 2024. Copies of the “Certified Mail Receipts” confirming the dates on which the letters were sent are attached as part of **Exhibit D**.

6. To date, twelve signed United States Postal Service Form 3811 “green cards” have been returned. Copies of the returned “green cards” are attached as a part of **Exhibit D**. One notice letter is marked “delivered, individual picked up at postal facility” according to United States Postal Service (USPS) tracking data, which is attached as part of **Exhibit D**. Four notice letters are marked “delivery attempt” according to USPS tracking data, which is attached as part of **Exhibit D**. There are no unaccountable notices.

7. A copy of the letter (with the applicable enclosure) sent to the County Judge Executive has been attached as **Exhibit E**. A copy of the “Certified Mailing Receipt” and a copy of the USPS Form 3811 “green card” for this mailing are also attached as a part of **Exhibit E**.

**WHEREFORE**, Applicant respectfully request that the PSC accept the foregoing information for filing, and having met the requirements of KRS §§ 278.020(1), 278.650, and 278.665 and all applicable rules and regulations of the PSC, find the application non-deficient and proceed to grant a Certificate of Public Convenience and Necessity to construct and operate the WCF at the location set forth in the subject application.

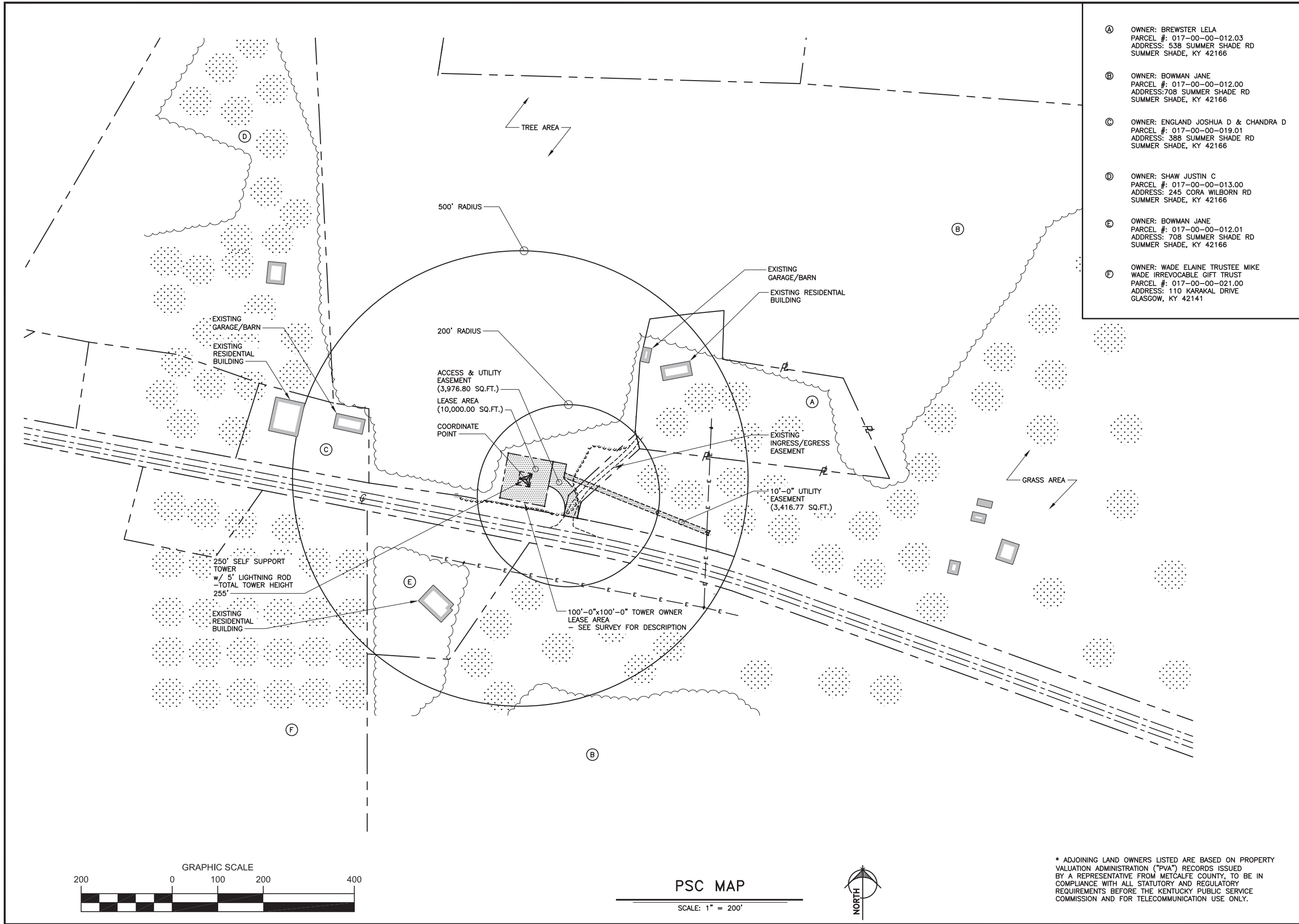

Map depicting landowners and structures within 500' of the site

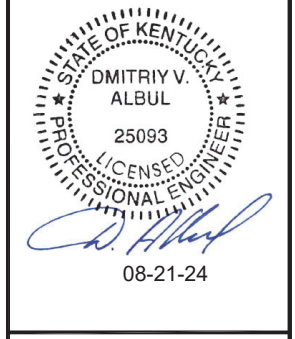

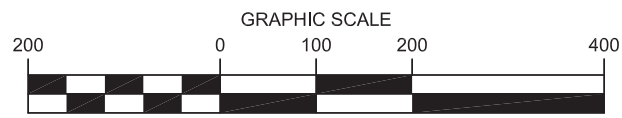

Harmoni Towers AssetCo LLC, a Delaware limited liability company, and Cellco Partnership d/b/a Verizon Wireless are filing an application with the Kentucky Public Service Commission ("PSC") to construct a new wireless communications facility on a site located on Sumer Shade Road (Parcel Address: 708 Summer Shade Road / E911 address: 486 Summer Shade Road), Summer Shade, KY 42166 (36° 53' 46.16" North latitude, 85° 44' 03.79" West longitude). The proposed facility will include a 250-foot tall tower with a 5-foot tall lightning arrestor attached at the top for a total height of 255 feet, plus related ground facilities. This facility is needed to provide improved service for wireless communications in the area.

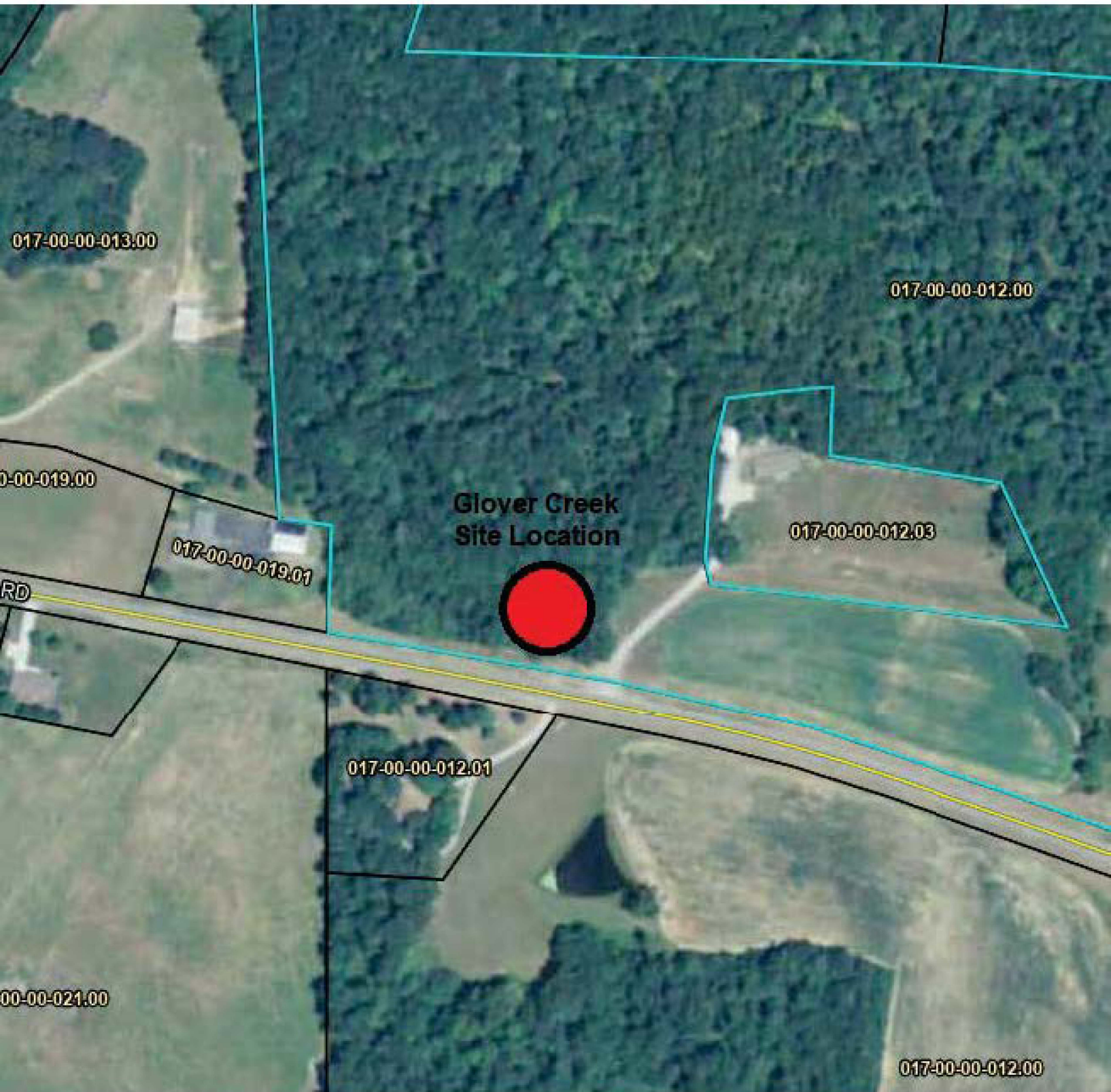
