## **VERIFIED APPLICATION**

Kentucky Utilities Company ("KU" or "Company") respectfully petitions the Kentucky Public Service Commission ("Commission") by verified application pursuant to KRS 278.218 and 807 KAR 5:001 Section 8 to issue an order authorizing KU to sell to a prospective third-party buyer KU's assets located at 2201 West Cumberland Avenue, Middlesboro, Kentucky 40965, which include a 0.16-acre parcel of land, an 8,400 square-foot, two-story office building, and a parking lot (collectively, "Middlesboro Business Office"). (A copy of the current Middlesboro Business Office deed is attached hereto as Application Exhibit 1.) In support of this Application, KU states as follows:

- 2. The Company may be reached by electronic mail at the electronic mail addresses of its counsel set forth below.
- 3. KU was incorporated in the Commonwealth of Kentucky on August 17, 1912, and attests that it is in good corporate standing.

4. KU is a public utility, as defined in KRS 278.010(3)(a), engaged in the electric business. KU generates and purchases electricity, and it distributes and sells electricity at retail in the following counties in central, northern, southeastern, and western Kentucky:

- 5. KU is wholly owned by LG&E and KU Energy LLC, a subsidiary of PPL Corporation.

- 7. KRS 278.218 requires prior approval for transfers of electric utility assets if the assets have an original book value of \$1,000,000 or more and are being transferred for reasons other than obsolescence or will continue to be used to provide the same or similar service to the utility or its customers. The Commission is required to grant approval if the transfer is for a proper purpose and consistent with the public interest.
- 8. In late 2022, KU and Louisville Gas and Electric Company ("LG&E") announced to customers that they planned to close all business offices due to a decline in walk-in transactions, increased customer use of self-service channels, and best practice among similar utilities.<sup>1</sup> KU and LG&E completed closing all business offices as of June 14, 2024.<sup>2</sup>
- 9. The Company's former Middlesboro Business Office permanently ceased public operations on May 31, 2024. KU intends to vacate the property no later than September 1, 2024.
  - 10. The original book value of the Middlesboro Business Office is \$1,407,783.
- 11. KU does not intend to use the former Middlesboro Business Office in future business operations, and it will no longer be used by or useful to KU once it is vacated. Nonetheless, the Middlesboro Business Office is not obsolete for purposes of KRS 278.218(1)(a) because the property is capable of being used by another entity.<sup>3</sup> Indeed, KU currently leases part

of the building to a CPA firm, though KU plans to terminate that lease as part of any sale of the property.

- 12. Because the Middlesboro Business Office is a utility asset with an original book value of more than one million dollars, and because the asset is being transferred by KU for reasons other than obsolescence, Commission approval under KRS 278.218 is required.
- 13. KU does not currently have a buyer identified for the former Middlesboro Business Office. The Commission has previously granted approvals under KRS 278.218 for asset transfers where the prospective buyer was unknown.<sup>4</sup> KU will market the property for sale to achieve the most favorable sales price while balancing the continued expense of ongoing maintenance of the property. Once a buyer is identified, KU proposes to transfer the Middlesboro Business Office to the selected buyer. If KU identifies a buyer and enters into a sales contract during the pendency of this proceeding, KU will file the contract into the record of this proceeding.
- 14. KU will not sell the Middlesboro Business Office to an affiliate, as the term is defined in KRS 278.010(18),<sup>5</sup> or to an entity that would continue to use the property to provide the same or similar services to KU or its customers.<sup>6</sup>
- 15. KU respectfully asks the Commission to grant the relief requested herein prior to the expiration of the eight-month period by which the Commission must act on this Verified

Application.<sup>7</sup> Approving the requested relief as soon as reasonably practicable will assist KU in marketing the property.

WHEREFORE, Kentucky Utilities Company respectfully asks the Commission to issue an Order (1) finding that the transfer of KU's former Middlesboro Business Office to a prospective third-party buyer is for a proper purpose and consistent with the public interest and (2) approving the transfer of the asset subject to two conditions:

- (a) The buyer will not be an affiliate of KU as the term is defined in KRS 278.010(18); and
- (b) The buyer will not use the Middlesboro Business Office to provide the same or similar services to KU or its customers.
