B. Materials Expense

Took pricing of listed materials from our top 3 vendors used by WCWD and averaged the prices of all. (included on attached material sheet)

C. Service Pipe Expense

Took pricing of service pipe from our top 3 vendors used by WCWD and averaged the prices of all. (included on attached material sheet)

D. Installation Labor Expense

WCWD averages 2 men at 1 hour each of labor per short service installation, and average 2 men at 3.5 hours each of labor per long service installation with an average wage of \$19.10.

E. Installation Equipment Expense

WCWD board set forth equipment hourly rates during the August of 2015 meeting of \$60/hr. We average 1 equipment hour for short service installation and average 3 equipment hours for long service installation.

F. Installation Miscellaneous Expense

Hourly average for WCWD's main 2 distribution workers is \$19.10
