**LICKING VALLEY RURAL ELECTRIC COOPERATIVE CORPORATION’S  
MOTION FOR REHEARING**

---

Comes now Licking Valley Rural Electric Cooperative Corporation (“Licking Valley”), by counsel, pursuant to KRS 278.400 and respectfully requests the Kentucky Public Service Commission (“Commission”) grant rehearing on its June 6, 2025 Order (“Final Order” or “the Order”) in the above styled case. In support of this motion, Licking Valley respectfully states as follows:

1. On August 8, 2024, Licking Valley filed an application requesting an adjustment of rates. On August 16, 2024, the Commission entered an order that suspended the effective date of Licking Valley’s proposed rate increase and tariffs for five months, up to and including February 8, 2025. On June 6, 2025, the Commission issued its Final Order

2. On August 30, 2024, in Case No. 2023-00014, *Electronic Examination of the Application of the Fuel Adjustment Clause of East Kentucky Power Cooperative, Inc. Cooperatives from November 1, 2020 through October 31, 2022*, the Commission ordered an increase in base

energy rates of \$0.01201 per kWh adjusted for line loss. The increase in the base energy rates was effective for service rendered on or after September 1, 2024.<sup>1</sup>

3. KRS 278.400 governs motions for rehearing, which provides the Commission with the ability to correct findings based on material errors or omissions, or to correct findings that are unreasonable or unlawful.<sup>2</sup>

4. After reviewing the rates approved by the Commission<sup>3</sup>, Licking Valley believes the Commission did not properly account for the additional \$0.01201 in base energy rates that occurred in Case No. 2023-00014 during the pendency of this matter.

WHEREFORE, Licking Valley respectfully requests the Commission grant rehearing to include the additional \$0.01201 in base energy rates from Case No. 2023-00014 in the calculation of Licking Valley's base rate adjustment.
