I, Earl Bush, as chairman of the Board of Augusta Brooksville Bracken Industrial Authority ("ABBIA"), hereby state for an affidavit as follows:

1. The 5400 of linear water line distribution feet and connections that was developed by ABBIA, and presented to the KY Public Service Commission by request for transfer of water assets herein, (Case No. 2024-00222), has been completed and the contract between itself and Bracken County Water District ("BCWD") has been fully implemented, and the water assets were transferred as of December 10, 2024.

Therefore, ABBIA hereby acknowledges transfer of all water assets (identified as 5400 feet of 8" PVC Water Main, SDR 17 class 250; Tapping sleeve and valve; leak detection meter; 4" gate valve and box x 3; 8" gate valve and box x 2; 40 feet of steel casing, bore and jack; 60 feet of pvc casing, open cut; flush hydrant assembly, new customer mete set) and as referenced in a filing herein, on July 12, 2024, identified as Exhibit "A", Contractual Agreement, paragraph A, page 2, (filed July 12, 2024, Exhibit_A_Contractual_Agreement.pdf), and as proven by acknowledgment of contract completion, attached hereto.
3. ABBIA hereby certifies no alterations, amendments and/or modifications to the proposed engineering specifications, construction specifications and project specifications were made. *Also. See affidavit of Engineering firm who engineered project and oversaw construction specifications.*
