ATMOS ENERGY CORPORATION’S NOTICE OF INTENT TO PLACE PROPOSED
RATES INTO EFFECT

Comes now Atmos Energy Corporation (“Atmos Energy”) by and through counsel, and states as follows for its Notice pursuant to KRS 278.190(2) and the Commission’s September 27, 2024 Order suspending Atmos Energy’s proposed Pipeline Replacement Program (“PRP”) Rider Rates until October 2, 2024 in this matter. Atmos Energy respectfully states as follows:

1. On July 31, 2024, Atmos Energy filed its Application for PRP Rider Rates for the twelve-month period commencing October 1, 2024.
2. The Commission entered an Order on September 27, 2024, accepting the Application for filing and suspending the tariff until October 2, 2024, to investigate the proposed PRP charges. The September 27, 2024 Order permitted Atmos Energy to begin to charge the proposed PRP Rider rates subject to refund if notice was provided pursuant to KRS 278.190(2).
3. Pursuant to the September 27, 2024 Order and KRS 278.190(2), Atmos Energy hereby gives notice that it will put the proposed PRP Rider Rates into effect on October 2, 2024. Atmos Energy will maintain its records in a manner as will enable it, its customers, and/or the Commission, to determine the amounts to be refunded and to whom, in the even a refund is awarded.

WHEREFORE, based on the foregoing, Atmos Energy gives the Commission notice of putting its proposed PRP Rider Rate into effect subject to refund beginning October 2, 2024.
