

## RESOLUTION

A RESOLUTION OF THE WOOD CREEK WATER DISTRICT, PROPOSING ADJUSTMENTS TO ITS WATER RATES AND AUTHORIZING ITS REPRESENTATIVES TO FILE AN APPLICATION WITH THE PSC SEEKING APPROVAL OF THE PROPOSED RATE ADJUSTMENTS

WHEREAS, the Wood Creek Water District (District) of London, is a water district created and organized under provisions of KRS Chapter 74. The District is subject to the jurisdiction of the Kentucky Public Service Commission (PSC);

WHEREAS, the PSC ordered the District in Case No. 2023-00110 to file an application for a traditional adjustment in rates or an Alternative Rate Adjustment; and

WHEREAS, KRS 278.180 and 807 KAR 5:076 provide the legal mechanism for the District to propose adjustments to its sewer rates and charges;

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Commissioners of the District as follows:

SECTION 1. The facts, recitals and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.

SECTION 2. The District proposes to adjust its monthly sewer rates and charges as set forth in Appendix A, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The proposed rates and charges set forth in Appendix A are subject to any adjustments that may be made by the PSC. The proposed rate adjustment shall not become effective until PSC approval has been obtained.


SECTION 3. The Chairman is hereby authorized and directed to prepare, execute and file with the PSC, by utilizing the Alternative Rate Adjustment Procedure for Small Utilities set forth in 807 KAR 5:076, an Alternative Rate Filing (ARF) Application, Tariff Sheets and all other documents that may be required by the PSC.

SECTION 4. The Chairman, Office Manager and all others to whom the Chairman may delegate certain responsibilities are hereby further authorized and directed to take any and all other actions and to execute and deliver any and all other documents as may be reasonably necessary to implement this Resolution.

SECTION 5. This Resolution shall take effect upon its adoption.

ADOPTED by the Commission of Wood Creek Water District at a meeting held on July 29, 2024, signed by the Chairman and attested by the Secretary.


