MOTION TO AMEND PROCEDURAL SCHEDULE

Comes now East Pendleton Water District and Pendleton County Water District (collectively referred to as “Districts”) to request that the Commission amend the Procedural Schedule attached as Appendix A to its Order dated August 12, 2024.

Pursuant to the Procedural Schedule attached to the Commission’s Order:

- 1) all Initial Requests for Information to the City of Falmouth (“Falmouth”) were to be submitted to the Commission no later than September 13, 2024;
- 2) Falmouth’s responses to the Initial Requests for Information were to be submitted no later than September 27, 2024; and
- 3) all Supplemental Requests for Information to Falmouth are to be submitted no later than October 11, 2024.

In accordance with the Procedural Schedule, the District’s submitted an Initial Request for Information to Falmouth on September 13, 2024. Although September 27, 2024 has passed, Falmouth has not submitted responses to the District’s Initial Request for Information. Receipt and review of Falmouth’s responses is necessary for the Districts to prepare Supplemental Requests for Information to Falmouth.

The Commission's Procedural Schedule provides two weeks for the Districts to prepare and submit Supplemental Requests for Information to Falmouth after receiving Falmouth's responses to the District's Initial Request for Information. The Districts request that the Commission amend the Procedural Schedule to change the date upon which Supplemental Requests for Information are due from October 11, 2024, to two weeks from whatever date Falmouth provides complete responses to the District's Initial Request for Information.
