On behalf of Navitas KY NG, LLC (“Navitas”), please accept this letter and its enclosure in response to your letter of August 29, 2024, regarding Navitas’ Application for Alternative Rate Filing (“ARF”) submitted in the above-referenced matter on August 2, 2024. Your letter described two (2) filing deficiencies, both concerning detail about non-recurring fees referenced in the Customer Notice.
