RE: New Frontiers Solar Park Community Outreach


Dear Neighbor:

Clover Creek Solar Project LLC d/b/a New Frontiers Solar Park (“New Frontiers”), is proposing to develop and construct a 100-megawatt solar electric generating facility and nonregulated electric transmission line to be located in Breckinridge County, Kentucky. The proposed solar project will be situated on approximately 1,100 acres of land, with an address of 448 Highway 992, Hardinsburg, Kentucky 40143. The project will consist of photovoltaic panels and their associated racking systems, inverters, collection system, project substation, transmission line, and other equipment.

New Frontiers is required to file an application with the Kentucky State Board on Electric Generation and Transmission Siting (“Board”) to obtain a certificate of construction for the proposed electric generating facility and nonregulated electric transmission line. This filing will occur in the coming weeks. This proposed construction is subject to approval by the Board, which can be reached at P.O. Box 615, 211 Sower Boulevard, Frankfort, Kentucky 40602-0615, or via phone at (502) 564-3940.

A person who wishes to become a party to a proceeding before the Board may, by written motion filed no later than thirty (30) days after the application has been submitted, request leave to intervene. A party may, upon written motion filed no later than thirty (30) days after an application has been filed, request the Board to schedule an evidentiary hearing at the offices of the Public Service Commission. A request for a local public hearing or local public information meeting shall be made by at least three (3) interested persons who reside in the county in which the plant is proposed to be located. The request shall be made in writing and shall be filed within thirty (30) days following the filing of a completed application.

Human trafficking investigation leads to multiple arrests

A joint investigation involving numerous agencies, including the Daviess County Sheriff's Office, resulted in three men being charged with attempted human trafficking.

Daviess County Sheriff Brad Youngman said the investigation, dubbed "Operation Phantom, focused on sex trafficking and culminated in a series of arrests over the weekend.

"This is something I had spoken with Attorney General (Russell) Coleman about once he took office, about wanting to do something about human trafficking," Youngman said Monday.

"Human trafficking is the fastest-growing crime in the world, and it's everywhere," Youngman said. "This is something the AG's office knows how to do."

The investigation involved "communications" between undercover investigators and people who "expressed intent to engage in sexual activity with children," a sheriff's office press release says.

Youngman said he could not discuss details of the investigation, but said, "we were able to identify individuals we believe were looking for that type of activity."

Investigators charged Robert B. Pierce, 64, of the 1700 block of Mallard Place, Abbel Getu, 32, of the 3000 block of Waterside

Way, and Justin L. Chancy, 41, of Reynolds Station with attempted human trafficking, victim under age 18.

The news release says the investigation is continuing and more arrests are anticipated.

Human trafficking is defined by state law, in part, as "commercial sexual activity through use of force, fraud or coercion." When a person is under the age of 18, force, fraud or coercion is not necessary to prove a person was being trafficked.

Attempted human trafficking of a minor is a class B felony, punishable upon conviction by between 10 and 20 years in prison.

The arrests were made Oct. 17-19, which was only

a small part of the investigation, Youngman said.

"There was a lot of work that went into it on the front end," he said.

Sheriff's office reports say two other men identified in the investigation, Jefferson Suentz-Cruz, 23, of Hartford and Jeremiah Phillips, 24, of the 1200 block of Werner Avenue, were charged with promoting prostitution, which is a class A misdemeanor.

"The cases will stay here," Youngman said. "Our Commonwealth's Attorney will be the one prosecuting them."

Numerous other agencies were involved, including the U.S. Attorney for western Kentucky, the Commonwealth's Attor-

ney's office, the Daviess County Attorney's office, the Secret Service, the Kentucky State Police, Owensboro-Daviess County 911 dispatch, the jail, New

Beginnings Sexual Assault Support Services and the Internet Crimes Against Children Task Force.

"It was definitely a team effort," Youngman said.

State receives \$1.4 billion for rural communities

FRANKFORT — Gov. Andy Beshear joined U.S. Department of Agriculture Rural Utilities Service Administrator Andy Berke on Monday to announce that up to \$1.4 billion in federal funds will increase Kentucky's access to clean energy, education and health care, plus support economic growth in rural communities.

During a Frankfort press conference, Berke said the up to \$1.4 billion in grants and forgivable loans are under the USDA's Empowering Rural America program and will allow East Kentucky Power Cooperative to provide renewable energy that will help power homes and businesses in rural Kentucky.

The project also is expected to help rural communities attract new business and support economic growth and job creation.

"When we transition to clean energy, we lower the toxic pollution in our air and water," Berke said. "At the same time, this funding will keep costs low and allow rural Kentuckians to save money on their electric bills."

Specifically, EKPC will

construct or procure 757 megawatts of renewable energy for rural portions of Kentucky, as well as improve the regional transmission grid to support renewable projects and increase energy efficiency. These efforts will also reduce pollution — including carbon dioxide emissions — by more than 2.3 million tons annually, the equivalent of avoiding the pollution from 554,000 gasoline-powered cars annually.

Tony Campbell, president and CEO of EKPC, said, "These funds will support renewable resources, including the

proposed new solar facilities in Fayette and Marion counties, which will advance EKPC's strategy to cut carbon intensity and diversify its generating portfolio."

Gov. Beshear called the funding a game-changer.

"Many of the big economic development projects we're working on — and we're working on a bunch of them — have business leaders telling us, 'You've got to provide us this much in renewable energy by this date,'" he said. "And today's award

means East Kentucky Power is going to help us meet this demand and land more projects and more jobs in the coming years."

The USDA also announced the awarding of more than \$5.5 million in Distance Learning and Telemedicine Grants. These funds will help deliver virtual health care services to more than 27,700 Kentuckians and distance learning connections to more than 12,200 students and educators in rural areas.

A person who wishes to become a party to a proceeding before the Board may, by written motion filed no later than thirty (30) days after the application has been submitted, request leave to intervene. A party may, upon written motion filed no later than thirty (30) days after an application has been filed, request the Board to schedule an evidentiary hearing at the offices of the Public Service Commission. A request for a local public hearing or local public information meeting shall be made by at least three (3) interested persons who reside in the county in which the plant is proposed to be located. The request shall be made in writing and shall be filed within thirty (30) days following the filing of a completed application.
