




# Clover Creek Solar Park

Breckinridge County, KY

Clover Creek Solar Park will be located in Breckinridge County, KY, just outside the town limits of Hardinsburg. The area is mostly agricultural, used for both crops and ranching. This solar park project would mark our first solar park located in the state of Kentucky.



## PROJECT MAP




# Project Status

## POTENTIAL PROJECT LOCATION



The purple boundary is the general area that we are currently exploring for the project.

We are still in the process of determining the project layout through discussions with participating landowners.

We pay careful attention to the locations of homes and other community features to ensure solar panels are properly set back and/or screened with vegetation to reduce any impacts.

Many areas will also be excluded due to biological, cultural, or environmental constraints.

## HIGH-LEVEL PROJECT SCHEDULE

The project timeline is also an approximation. We are currently exploring paths forward that would have us on track to be producing power as early as September 2024, but we will communicate a more precise timeline once more factors are confirmed.

**CITY OF CLOVERPORT, KENTUCKY ORDINANCE NO. 2022.09.01****AN ORDINANCE TO AMEND CHAPTER 50 AS IT RELATES TO METER DEPOSIT CHARGE AND SERVICE FEES**

WHEREAS, by Ordinance passed on October 15, 1985, there was codified the deposit charges and service fees for water meters for the City of Cloverport; and

WHEREAS, the City Council now desires to amend Chapter 50 of the Code of Ordinances, in part, to amend the charges for meter service fees; and

WHEREAS, pursuant to KRS 82.405(2) the City Council of the City of Cloverport, Kentucky, makes the following resolution:

1. That Chapter 50 of the Code of Ordinances "Water and Sewer Regulations" is amended, in part, as follows:

Sec. 20,080. - Meter Deposit Charge and Service Fees,

In addition to the connection charges set forth in this subchapter, all customers except residential property owners, shall pay a meter deposit of \$50.00 to the city for water service before such customers shall be entitled to service. Such deposits, less any unpaid charges, shall be refunded to the customer, his or her heirs or assigns, whenever the customer notifies the city legal to disconnect or terminate service to that customer, no meter deposit shall be required of residential property owners. The meter service fee shall be \$75.00.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLOVERPORT, BRECKINRIDGE COUNTY, KENTUCKY, AS FOLLOWS:

**SECTION I**

THE FINDINGS OF FACT RECITED HEREIN ABOVE ARE HEREBY ADOPTED, AFFIRMED, AND INCORPORATED BY REFERENCE HEREIN.

**SECTION II**

THAT CHAPTER 50 OF THE CITY OF CLOVERPORT CODE OF ORDINANCES IS HEREBY AMENDED TO INCLUDE THE FINDINGS OF FACT RECITED HEREIN ABOVE.

**SECTION III**

A COPY OF THIS ORDINANCE SHALL BE RECORDED IN THE OFFICE OF THE BRECKINRIDGE COUNTY COURT CLERK.







# Clover Creek Solar Park

Breckinridge County, KY

The solar park will be located in Breckinridge County, KY, just outside the town limits of Hardinsburg. The area is mostly agricultural, used for both crops and ranching. This solar park project would mark our first solar park located in the state of Kentucky.



**Preserving the natural ecology and beauty of Breckinridge County is a priority for this project.**

Where possible, EDPR will maintain natural vegetation and tree stands to protect ecological environments and provide visual screening between homeowners and the project. In other areas, EDPR will work with a landscaper to plant and maintain regional species of vegetation around the project. This vegetation will be planted to create a natural visual buffer in areas where the project is close to residences. EDPR plans to work closely with landowners and the County to ensure that visual impacts of the project are minimized.



# About Solar Technology


Solar is a critical and rapidly growing part of America's electric grid, producing enough energy to power more than 23 million homes nationwide and counting.<sup>1</sup>

Solar projects are safe, clean, and have minimal impact on the land while providing a valuable economic boost to the rural economies that host them.

It would take less than 0.6% of total U.S. landmass to power the entire country with solar PV.<sup>2</sup> This represents half as much land as is currently being used to grow corn for ethanol production.<sup>3</sup>




Solar is affordable to build and maintain, helping boost America's energy independence in the process. The price of solar has been falling for years, dropping by about 70% since 2010. Average operation and maintenance costs have fallen nearly 60% since 2011. In many cases, solar energy is cheaper than traditional forms of generation,<sup>4</sup> giving utilities and corporate off-takers access to reliable, cheap energy at a fixed price. These guaranteed rates help keep consumer costs low and stable.



Requiring no water to generate power, solar energy saves 136 billion gallons of water each year that would otherwise be consumed by the traditional power industry.<sup>5</sup>

U.S. solar also avoids 81 million metric tons of carbon pollution annually, which is the equivalent of removing 17.2 million cars from the road.<sup>6</sup>

## HOW A SOLAR PARK GENERATES ENERGY



The solar panels absorb sunlight and generate direct current (DC) electricity. Many have trackers installed to tilt toward the sun as it moves across the sky.

The electricity goes through an inverter, converting it to alternating current (AC) electricity.

Then it flows into the grid, supporting the region's energy needs.

# Solar Projects & the Land

EDPR works with landowners who recognize the environmental and economic benefits of generating solar power on their land. This project will be sited entirely on private land.



## Preserving the Land for the Next Generation

In order to host a solar park, a section of a participating landowner's property will be fenced off and planted with an environmentally-friendly seed mix designed for the local climate and soil type. During the 30 year lifespan of the project, the land is able to rest and replenish.

A solar park gives the land hosting it a rest and a chance to recover. This rest period can help boost soil quality and increase local biodiversity, leaving the land recovered and ready to serve future generations after the solar park's life.<sup>1</sup>



## Returning to Production After the Solar Park's Life

At the end of the project's useful life, the project will be decommissioned. The equipment will be removed and the land can return to its original use, including farming, ranching or wildlife habitat.

Through the project leases, EDP Renewables (EDPR) has provided financial assurances for the decommissioning of the project and will also pursue a decommissioning agreement with the County. Together, these agreements will require EDPR to return the site to a condition suitable for the land's use prior to construction.



## Safeguarding the Environment

As with all utility-scale solar parks in the U.S., the project will undergo extensive studies and approval processes through local, state, and federal channels regarding natural resources, habitat conservation, and wildlife impacts. Through careful site selection and thoughtful project design, impacts to the land and nearby wildlife can be mitigated or entirely avoided.

Silicon-based PV panels are made of safe, well-tested materials commonly used in building and household products. The panels are fully sealed and do not contain any liquids.

# Solar Park Construction

Building a solar park is a major construction project that takes approximately a year to complete and employs hundreds of people. Here are some of the goods and services we can source locally:

## TECHNICAL & CONSTRUCTION EMPLOYMENT

- Civil contractors
- Concrete supply and delivery
- General laborers
- Safety staff
- Excavation and restoration
- Gravel supply and delivery
- Heavy equipment operators

## SERVICES

- Accommodations and catering
- Vehicle and equipment maintenance
- Vehicle and equipment rentals
- Security
- Fuel supply

Throughout the construction process, we work closely with local stakeholders and officials to ensure everyone is informed and construction activities are minimally disruptive.

## 1 SITE PREPARATION

To prepare a site for a new solar project, vegetation and large rocks are first removed. In some cases, a grading technique is employed to provide a level foundation for the construction of the solar modules. Great care is taken to salvage topsoil, prevent erosion, and maintain natural drainage patterns.

## 2 SECURITY FENCE

To protect the public during construction activities, as well as to prevent trespassing and vandalism, a chain link fence is erected around the perimeter of the project location.

## 3 DRIVING & DRILLING PILES

Following site preparation, metal beams (typically steel or aluminum) are spaced out and inserted into the ground using pile-drivers to serve as the foundation for the solar modules.

## 4 INSTALLING TABLES, TRACKERS, & PANELS

A typical solar park is comprised of thousands of photovoltaic (PV) panels that are mounted to tables and affixed to the foundation to form a solar array. In most cases, trackers are installed to aim the panels toward the sun and increase power production throughout the day.

## 5 LAYING UNDERGROUND CABLES

Buried electrical collection cables are installed to connect the solar arrays, inverters, and transformer. The buried lines are contained within the project location and buried to a minimum depth of three feet.

## 6 INSTALLING INVERTERS & TRANSFORMERS

The electricity generated by the PV panels is in the form of direct current (DC). Inverters are installed to convert the DC output of the PV cells into alternating current (AC) suitable for supplying the electrical grid. The AC power then goes through a transformer to increase the voltage before connecting to the electrical grid.


## 7 INTERCONNECTION

The power then passes from the project substation, where the voltage was increased, to a substation owned by the utility. From the utility's substation, the renewable electricity will be sent to homes, businesses, and utilities.

## 8 FULLY OPERATIONAL

Once the solar project is complete, it will be monitored on a continuing basis to ensure all components of the system are operating properly. Vegetation within the project area will be maintained, and the solar panels will be washed on a regular basis.
